Notification of Medical Marijuana Product Recall

The Marijuana Regulatory Agency (MRA) is issuing this health and safety advisory bulletin due to marijuana flower which failed safety compliance testing for total yeast and mold in July and August 2020. The test results for all the affected products failed testing standards for the medical market but passed testing standards for the adult-use market.

All affected marijuana flower products will have a label on their packaging that indicates the license number of the marijuana facility that sold the marijuana product as well as tag number assigned to the product in the statewide monitoring system.
