/ CONSENT ORDER AND STIPULATION

CONSENT ORDER

On September 23, 2020, the Marijuana Regulatory Agency (MRA) issued a formal complaint

against the medical marijuana processor facility license (PR-000005) of Choice Labs, LLC

("Respondent") under the Medical Marihuana Facilities Licensing Act (MMFLA), MCL 333.27101 et seg.,

and the administrative rules promulgated thereunder. The formal complaint alleged Respondent violated

Mich Admin Code, 333.233(5), 333.238(1), and 333.235(5).

The executive director reviewed the stipulation contained in this document and agrees the public

interest is best served by resolution of the formal complaint. Therefore, the executive director finds that

the allegations contained in the formal complaint are true and that Respondent violated Mich Admin Code,

R 333.233(5), and 333.235(5).

Accordingly, for these violations, IT IS ORDERED:

1. Respondent must pay a fine in the amount of Three Thousand and 00/100 dollars (\$3,000.00). This fine shall be paid within 30 days of the effective date of this order by check or money order made

payable to the State of Michigan with enforcement number "20-00073" clearly displayed on the check or money order. Respondent shall mail the fine to Department of Licensing and Regulatory

Affairs, Marijuana Regulatory Agency, PO BOX 30205, Lansing, Michigan 48909.

2. If Respondent fails to timely pay the fine, Respondent's license shall be suspended until payment

is received.

- 3. The paragraph of the formal complaint alleging a violation of Mich Admin Code, R 333.238(1), is DISMISSED.
- 4. Respondent must ensure that it is complaint and stays in compliance with the Weights and Measures Act, MCL 290.601, *et seq.*, and any administrative rules promulgated thereunder.
- 5. Any administrative hold placed on product in the statewide monitoring system as a result of this investigation is hereby lifted, and that product may be processed, sold, or transferred in compliance with MCL 333.27101 *et seq.*, and the administrative rules.
- 6. Unless otherwise specified in this order, Respondent shall direct any communications to the MRA that are required by the terms of this order to MRA-LegalHearings@michigan.gov.
- 7. Respondent shall be responsible for all costs and expenses incurred in complying with the terms and conditions of this consent order.
- 8. If Respondent violates any term or condition set forth in this order, Respondent will be subject to fines and/or other sanctions under section 407(1) of the MMFLA, MCL 333.27407(1), and Mich Admin Code, R 420.806.
- 9. Upon timely payment of the fine by Respondent, the matters set forth in the formal complaint shall be deemed resolved and closed subject to this Consent Order.

This order shall be effective on the date signed by the MRA's executive director or his designee, as set forth below.

STIPULATION

The parties stipulate to the following:

1. The facts alleged in the formal complaint are true and constitute a violation of the

administrative rules promulgated under the MMFLA.

2. Respondent understands and intends that by signing this stipulation, Respondent is waiving the

right under the MMFLA, administrative rules promulgated thereunder, and the Administrative

Procedures Act of 1969, MCL 24.201 et seq., to require the MRA to prove the charges set forth

in the formal complaint by presentation of evidence and legal authority, and to present a defense

to the charges.

3. The parties considered the following in reaching this agreement:

a. Respondent alleged that it inadvertently entered the marijuana product in question into

its Metrc inventory before the product was weighed.

b. Respondent provided documentation that its surveillance system company was delayed

in getting the surveillance system installed.

c. Although there was a delay in the surveillance system being installed, after the installation of the surveillance system, Respondent went approximately two weeks without an operational camera located in a room where marijuana was handled and

weighed.

d. Respondent was cooperative and wishes to resolve the allegations without the need for

and expense of an administrative hearing.

4. The MRA's enforcement division director or her designee must approve this proposed

agreement before it is forwarded to the MRA's executive director or his designee for review

and issuance of the above consent order. The parties reserve the right to proceed to an

administrative hearing without prejudice to either party, should the MRA's enforcement

division director, executive director, or their designees reject the proposed consent order.

By signing this stipulation, the parties confirm that they have read, understand, and agree with the

terms of the consent order.

FORMAL COMPLAINT

The Marijuana Regulatory Agency ("Complainant") files this formal complaint against

Choice Labs, LLC ("Respondent") alleging upon information and belief as follows:

1. The Marijuana Regulatory Agency (MRA) is authorized under the Medical Marihuana

Facilities Licensing Act (MMFLA), MCL 333.27101 et seq., and Executive Reorganization Order

No.2019-2, MCL 333.27001, to investigate alleged violations of the MMFLA and the

administrative rules promulgated thereunder, take disciplinary action to prevent such violations,

and impose fines and other sanctions against applicants and licensees that violate the MMFLA or

administrative rules.

2. Section 402(12) of the MMFLA provides that the expiration of a license does not terminate

the MRA's authority to impose sanctions on the license.

3. Section 206(c) of the MMFLA provides that the administrative rules must ensure the health,

safety, and security of the public and integrity of the marihuana facility operations.

4. Respondent's conduct as described below is a risk to public health and safety and/or the

integrity of marihuana facility operations.

Formal Complaint

FACTUAL ALLEGATIONS AND INTENDED ACTION OF THE MRA

- 5. Respondent holds an active state operating license under the MMFLA to operate a medical marihuana processor in the state of Michigan.
- 6. Respondent operated at 4499 Phelps Dr., Jackson, Michigan, 49201 at all times relevant to this complaint.
- 7. Following an investigation, the MRA determined that Respondent violated the MMFLA and/or administrative rules promulgated thereunder as set forth below:
 - a. On May 14, 2020, Respondent accepted Manifest 154672, a delivery of marijuana product, into the statewide monitoring system (METRC) without weighing the marijuana product.
 - b. It was later determined that the product from Manifest 154672 had multiple discrepancies:
 - i. Package 1A4050100004845000000497 Shipped weight: 15,784g Received weight: 12,740g Weight difference of -3,044g.
 - ii. Package 1A40501000048450000000485 Shipped weight: 7,190g Received weight: 15,567g Weight difference of +8,407g.
 - iii. Package 1A4050100004845000000486 Shipped weight: 5,289g Received weight: 11.599g Weight difference of +6,310g.
 - iv. Package 1A4050100004845000000487 Shipped weight: 4,698g Received weight: 10,288g Weight difference of +5,590g.
 - v. Package 1A4050100004845000000490 Shipped weight: 1,885.84g Received Weight: 2,000g Weight difference of +114.16g.
 - vi. Package 1A4050100004845000000481 Shipped weight: 3,343g Received weight: 3,627g Weight difference of +283.4g.
 - vii. Package 1A4050100004845000000483 Shipped weight: 2,069.8g Received weight: 2,398g Weight difference of +328.2g.

- viii. Package 1A4050100004845000000479 Shipped weight: 2,498.4g Received weight: 1,852g Weight difference of -646.4g.
 - ix. Package 1A4050100004845000000474 Shipped weight: 1,258.1g Received weight: 1,310g Weight difference of +51.9g.
 - x. Package 1A4050100004845000000162 Shipped weight: 1,992.2g Received weight: 2,666g Weight difference of +673.8g.
- xi. Package 1A4050100004845000000166 Shipped weight: 3,343.6g Received weight: 1,058g Weight difference of -2,285.6g.
- c. Based on the above, because Respondent accepted the product without weighing it and then determining that the shipment weight was inaccurate, Respondent failed to enter current inventory, including but not limited to product weight, into the statewide monitoring system in violation of Mich Code R 333.233(5).
- d. Based on the above, Respondent failed to identify and track its inventory consistently in the statewide monitoring system in violation of Mich Admin Code R 333.238(1).
- e. On May 28, 2020, Respondent did not provide video surveillance of product being initially weighed after being received at its processing facility. Respondent's inability to provide all video surveillance recordings upon request to the MRA is a violation of Mich Admin Code R 333.235(5).

THEREFORE, based on the above, the MRA gives notice of its intent to impose fines and/or other sanctions against Respondent's license, which may include the suspension, revocation, restriction, and/or refusal to renew Respondent's license.

Under MCL 333.27407(4) and Mich Admin Code, R 333.29494(2), any party aggrieved by an action of the MRA suspending, revoking, restricting, or refusing to renew a license, or imposing a fine, shall be given a hearing upon request. A request for a hearing must be submitted to the MRA in writing within 21 days after service of this complaint. Notice served by certified mail is considered complete on the business day following the date of the mailing.

Respondent also has the right to request a compliance conference under Mich Admin Code, R 333.294(1). A compliance conference is an informal meeting at which Respondent has the opportunity to discuss the allegations in this complaint and demonstrate compliance under the

MMFLA and/or the administrative rules. A compliance conference request must be submitted to the MRA in writing.

If Respondent fails to timely respond to this formal complaint, a contested case hearing will be scheduled to resolve this matter. The MRA reserves the right to review the formal complaint and amend it should this matter proceed to a contested case hearing.
