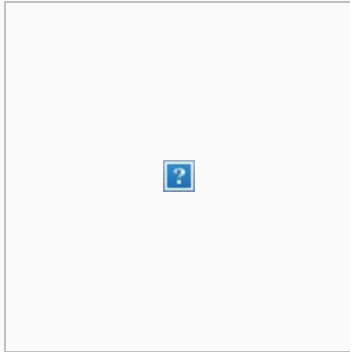

**COVID-19 Tests Available!**

Are you interested in delivering COVID-19 tests to your clients and staff? Would you like to be able to test at any time, day or night? All shelters, HARAs, street outreach programs, day shelters, RRH and PSH providers are now eligible to receive training and ongoing testing supplies through MDHHS. Abbot Labs original BinaxNow tests are easy to administer and results return in 15 minutes – no equipment needed. MDHHS will train your staff how to administer the test and read results. Data collection on test results is also minimal.

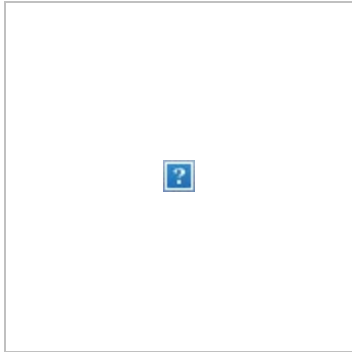
