Dear Michigan Retailer of Prepaid Wireless Service:

This letter is being sent to known retailers that may meet the criteria for billing and collecting of Michigan 911 charges for prepaid communications sales at the retail level. The Michigan 911 Office is aware that not all retailers receiving this notice may be sellers of prepaid communications service in Michigan, but given the ever-changing market, our office is sending this letter to the broadest retail group possible. Our intention is to make sure we keep up to date contact information on file for all prepaid communications retailers in Michigan.

Enclosed is an SNC-200 form for you to fill out and return the State 911 Office. Completion of the form is voluntary but having your information will allow us to provide faster notice to you in the event of a rate change. Additionally, not completing this form does not relieve you of your responsibility to comply with the requirements of the statute. If you are a retailer (seller) and are not a communications supplier (telephone company), indicate this by checking the third box in Section III B of the enclosed form. If you are the point of contact for more than one retail outlet, please submit a separate SNC 200 form for **each** of the outlets that file under a separate EIN. **Please submit completed forms by email to mspetsc@michigan.gov**

Please visit the Michigan Department of Treasury website at www.michigan.gov/emergency911charges to obtain the appropriate form for remitting the Michigan 911 charges. The retailers' responsibility is set forth in Michigan statute, MCL 484.1401c.
