Deputy Sheriff Eric Overall, Oakland County Sheriff's Office, was struck and killed by a suspect vehicle as he attempted to deploy stop sticks at approximately 12:30 a.m. Officers began pursuing the vehicle in the parking lot of the Lapeer County Jail after the man had made threats against law enforcement. The pursuit traveled into Oakland County on I-69 where the vehicle exited on M-15. Deputy Overall had deployed stop sticks and had taken up a position well off the roadway. The driver of the vehicle intentionally drove off the roadway and struck Deputy Overall. Pursuing officers immediately took the man into custody. Deputy Overall had served with the Oakland County Sheriff's Office for 22 years. End of Watch: November 23, 2017.

Officer Donald Kimbrough, Detroit Police Department, succumbed to complications of gunshot wounds sustained on August 25, 1972, while responding to a robbery. He and his partner, both in plain clothes, were in the area of a methadone clinic when they were informed that two men were shooting at people in the parking lot at the intersection of Belmont Street and Woodward Avenue. As the officers arrived on scene, they confronted one of the armed subjects walking from an alley to a car that had just pulled into an adjacent parking lot. The man complied with officer's orders, but a second subject sitting in the vehicle's driver's seat opened fire with a handgun striking Officer Kimbrough in the chest. The first subject then picked up the shotgun and fired at Officer Kimbrough's partner. Both officers returned fire as the suspects fled in the car.

Officer Kimbrough was transported to Henry Ford Hospital where it was determined that the bullet had lodged against his spine causing him paralysis from the waist down. Although confined to a wheelchair, he was able to return to limited duty until being medically retired in 1977. His health continued to deteriorate. He died of complications of the original gunshot wound on December 7, 2017. Officer Kimbrough was a U.S. Air Force veteran and had served with the Detroit Police Department for a total of seven years before medically retiring. He is survived by his son. End of Watch: December 7, 2017.

The Michigan Trooper that was killed in the line of duty is not classified as a LEOKA per the Federal Bureau of Investigation's guidelines; however, we wish to pay tribute to this Trooper.

Trooper Timothy J. O'Neill, Michigan State Police, was killed in a motorcycle crash, in Plainfield Township, at approximately 7:45 a.m. He was riding his department motorcycle when he was involved in a crash near the intersection of Wolverine Boulevard NE and Belding Road NE. End of Watch: September 20, 2017.
