

2019 Hate/Bias Crime in Michigan



DEFINITION - A Hate Crime is a criminal offense committed against a person or property which is motivated in whole or in part, by the offender's bias against a race, ethnic/national origin, religion, sexual orientation, or mental/physical disability group.

Michigan's Ethnic Intimidation Act, Act 328 of 1931, as amended, Section 750.147b, was written to allow for stricter penalties for hate crimes. Ethnic intimidation is a felony punishable by imprisonment for not more than two years, or by a fine of not more than \$5,000, or both.

Note: The Michigan Ethnic Intimidation Act, Act 328 of 1931 as amended, Section 750.147b, requires that all offenses be reported within an incident. Incidents where suspected bias motivation is Unknown or Other Bias are not published within this report.

Hate crime incidents are identified by the motivation of the offender(s). Law enforcement investigations determine the objective facts which lead to a reasonable conclusion that the offender's actions were motivated by bias against a race, ethnic/national origin, religion, sexual orientation, or mental/physical disability group. Accurate data collection of hate crimes depends heavily on effective training of law enforcement to recognize such incidents and the cooperation and desire of communities/victims to report these incidents to law enforcement.

Each year, the Michigan Incident Crime Reporting (MICR) data is "frozen" on a specific date for purposes of publishing the annual *Crime in Michigan* report which includes the Hate/Bias crime trends. The frozen set was created on March 11, 2020, for the 2019 *Crime in Michigan* publication.

The Federal Bureau of Investigation, Hate/Bias Program, updates the incidents that have been previously reported by the MICR Program until they publish their Hate/Bias report. The FBI's report only counts the Group A incidents. The counts below include Group A & B incidents. Because of the difference in dates and what is counted, cross-comparisons between the two data sets would yield inaccurate trend analysis.

ANALYSIS

Volume

The total number of reported hate crime incidents in 2019 was 524. This is a decrease of two percent when compared to 2018. These incidents involved 630 victims, 494 known offenders, and resulted in 630 offenses.

An incident is one or more offenses (crimes) committed by a person or group of persons acting together, at the same time and place. A victim of multiple hate crime offenses is counted for each offense.

Bias Motivation

In 2019, the largest percentage of hate crimes reported was racial in nature. The second most reported was religious motivated.

Offenders

White offenders accounted for sixty-four percent of the known offenders. Hate crime incidents can be perpetrated by multiple offenders of the same race.

Location

The location of Residence/Home accounted for thirty-six percent of the incidents. The second most common location was Highway/Road/Alley/Street/Sidewalk at sixteen percent.
