Legislative Action

Representative Calley introduced HB5026 in mid-June; this is a draft bill to renew the 911 Enabling Act which includes some changes to the current statute. It was referred to the Communications and Technology Committee in the House.

A special LAS meeting was held on October 1 to discuss the draft bill. A special SNC meeting was then held on October 5 to discuss HB5026 at which the SNC voted in support of the bill. Legislative hearings are scheduled in Lansing for Wednesday October 3 at 10:30am, and Wednesday October 13 at 10:30am. Please encourage your 911 and public safety agencies to attend and show support of HB5026. It is important for our Michigan Legislators to see our emergency response family supporting each other for the greater good of 911 and the services we provide.

911 Training

The 911 Training Subcommittee recently added two new members: Ms. Stephanie Lehman, Director at Barry County Central Dispatch and Ms. Marlana Terrian, Director at Clare County Central Dispatch.

With the end of the year approaching quickly, this is another friendly reminder that you will need to spend down training fund balances from 2019 or older by December 31, 2021. If you have a balance of older funds you would like to return to qualify for 2022 Training Funds, you will need to request an invoice by December 21, 2021, and return the balance of funds by December 31, 2021.

As a reminder for those who are training coordinators within your center, you may create a 2022 training fund application and begin to add your 2021 expenditures to help ensure all trainings have been entered by the training providers. If you need a refresher on how this process works, there is a training manual within the resource section of MiSNAP along with previous webinars that have been done. Ms. Hart and Ms. Stephens will be doing a session on MiSNAP at the Michigan Public Safety Communications Conference in October. As always, you can contact our office with any questions.

The ETS will be discussing locations and dates for 2022 in an upcoming meeting so stay tuned for a Save the Date!


