Michigan Veterans' Memorial Park (MVMP) Landscape Requirements/Recommendations

Basic Landscape Design & Requirements

- 1. Detailed plan of proposed landscape design shall be submitted after receiving preliminary design approval.
- 2. The plan shall be prepared by a landscape architect, registered in the State of Michigan and shall indicate, to scale, the location, spacing, starting size and description of each type of plant material utilized in the plan.
- 3. The Michigan Veterans' Memorial Commission (MVMPC), along with DTMB-Operations, shall consider design plans and materials in relation to their fulfillment of the basic landscape requirements/recommendations.

General Provisions

- 1. Landscaping shall be installed within 6 months of completion of the monument.
- All landscaping shall be continuously maintained by DTMB-Operations after installation.

 Ongoing maintenance cost will be covered by the maintenance fund established per Section 3.6.3 of the MVMP Monument Application Process-Guidelines and
- Requirements for Review and Acceptance.3. All landscaping will follow the standard requirements/recommendations as outlined:
 - a) Landscaping shall not extend more the 2 feet out from the monument base and approaching sidewalk
 - b) Plant spacing will follow traditional landscape recommendations, as provided by the landscape architect.
 - c) Native, drought resistant species that are tolerant to Michigan weather are required for longevity of the landscape.
 - d) Plant materials shall be of generally acceptable varieties and species, free from insects and disease.
 - e) Artificial plant materials are prohibited.
 - f) A limited mixture of hardy species is recommended, rather than a large quantity of different species, to produce a more aesthetic, cohesive design.
 - g) Trees will not be permitted around the monuments; to ensure security camera views are not obstructed.
 - h) Ground cover around plants/shrubs can be stones or wood chips/mulch.
 - i) All plants shall be guaranteed, by the Donor, for a period of 2 years, and those that are diseased or dead must be replaced in conformance with the landscape plan.
 - j) The diseased or dead plantings must be replaced with plantings of the same size as others currently on the site within 2 months.
 - k) Preservation and incorporation of existing trees in the MVMP is encouraged.
