Applications are accepted at any time throughout the year and positions will be filled as needed for the six positions. Applicants who would like to serve are to submit their application to the Michigan Women Commission, c/o Mary Engelman, 3054 West Grand Blvd, Suite 3-600, Detroit, MI 48202 or via e-mail with scanned signature to MDCR-WomensComm@michigan.gov.

The Millennial Advisory Committee is an advisory body to the Michigan Women's Commission. The goal of the millennial advisory committee is to identify issues of concern, create solutions and implement plans surrounding issues that impact Michigan's young and future female leaders. Members will be appointed by the Michigan Women's Commission and it gives members an opportunity to share their voice, build resumes, network and provide recommendations that make impactful change. Members will serve a two-year term.

The Millennial Advisory Committee meets in person two times per year (January and August) in locations around the state. Conference calls are to be held in between commission meetings (April and October). In order to remain on the advisory committee, members must attend one meeting and both conference calls. For in-person meetings, lunch is provided; mileage reimbursement is paid to those who attend.

**Applicants must submit an application with original or scanned signature to the Michigan Women's Commission. Applications without original or scanned signatures will not be reviewed. A signature ensures the applicant consents to the application. Please review the following application guidelines:**

1. Complete the form legibly with black ink.
2. Include a resume or personal history of activities/accomplishments as well as three(3) references.
3. Send complete application via email or mail.
4. E-mailed applications must include a scanned signature and date signed.
5. Please keep a completed copy of your application for your records.

Please note: All applicants will be notified regarding the status of their application and their application will be retained for one year.
