### **Call to Order**

Chair, Retired First Lieutenant Diane Garrison called the meeting to order at 1:28 p.m.

### **Excusing of Absent Members**

There were no absent members.

### **Approval of Agenda**

Bernard Kent moved, Craig Murray supported, to approve the agenda. The motion carried unanimously.

### **Approval of Minutes**

Insp. Steve O'Neill moved, Cheryl Schmittziel supported, to approve the minutes as presented. The motion carried unanimously.

### **New Pension Recipients**

The pension reports for February-April were reviewed. There were no questions or comments.

### **Special Report**

Jon Braeutigam from Bureau of Investments presented the 2016 Annual Investment Report.

Mita Drazilov from Gabriel Roeder Smith & Company presented the 2016 Annual Pension Valuations Report.

Louise Gates from Gabriel Roeder Smith & Company presented the 2016 Annual Health Valuations Report.

### **Old Business**

Chair started conversation on the report regarding benefit overpayments made to certain SPRS duty disability retirees on account of weekly worker's compensation offsets.

The five duty disability retirees at issue retired over 13 years ago. All now also receive weekly workers' compensation (WWC). For each, the WWC benefits when added to their duty disability pension, caused their combined annual benefits to exceed their annual final average compensation in contravention of MCL 38.1626(4). ORS discovered the overpayments in late 2016. Coordination of SPRS duty disability retirement pension benefits and WWC is required. Effective January 1, 2017, SPRS pension payments were adjusted to insure compliance with MCL 38.1626(4). An internal audit reveals no other similarly situated SPRS retirees. Limiting collection of overpayment to one year similar to that described in the worker's compensation statute was discussed. ORS was encouraged to consider resolution of the matter. To assist that effort, Insp. Steve O'Neill moved, Det. Sgt. Mitchell Stevens supported a motion for the Board to request the State to appropriate the amount that needs to be recouped beyond the one-year period and if the State will not appropriate the funds, to ask ORS to cover it from their budget. The motion passed with Mr. Murray dissenting. The Executive Secretary took the motion under advisement and recoupment against the individuals was placed on hold until the matter is resolved.
