The meeting was held via Microsoft Teams. The meeting began at 0900 hours on 16 December 2020 and adjourned at 0950 hours. The meeting agenda is attached and posted to the Bay West Collaborative Website.

1. Opening Remarks

P. Walz opened the meeting with a greeting and introductions. The meeting purpose was to discuss environmental restoration program work at the former Wurtsmith AFB.

2. Previous 18 November 2020 BCT Review

- a. 18 November 2020 meeting minutes are under EGLE review. B. Place will provide comments next week.
- b. Action Items EGLE
 - Review Wurtsmith UFP-QAPP and propose metrics that will be used for data quality
 assessment should QA/QC samples be collected by EGLE, including reconciliation if the
 agreed upon data quality metrics are not achieved. Status (summarized below) is unchanged
 from last month's BCT meeting.
 - 1. B. Place agreed to review the QAPP and the split sampling language. B. Place will draft a split sampling procedure for Air Force review and comment. The task is <u>not</u> to revise the QAPP. This task is in progress and should remain on the agenda.
 - 2. B. Place stated the split sampling language would be updated closer to the commencement of RI field work.
- c. Bay West / Air Force
 - i. Provide SS057 Annual O & M Cost. Completed on 30 November 2020 via email to B. Place.

d. Air Force

i. Follow up with M. Neller, EGLE on estimated time frame of storm sewer discharge fee review. D. Medina stated the legal review has been completed; the document will now be reviewed by Dr. Ter Maath. B. Place asked if the Air Force could provide any details. D. Medina stated that the Air Force would prefer to wait until Dr. Ter Maath completes his review.

3. DOCUMENT SUBMISSION SCHEDULE AND STATUS

Only documents that have changed status since the previous BCT were discussed. The anticipated submittal date will not be populated until review of the Draft document has been completed by the Air Force and the RTC preparation/concurrence process has begun.

Bay West

- a. Draft SS017 Site Closure Tech Memo will not be submitted. The Air Force Legal team would like an ESD or Proposed Plan/ROD Amendment to be used to document Site Closure.
- b. Draft SS072 Proposed Plan a modification is being worked on to complete an updated Risk Assessment and updated Feasibility Study, it should be awarded late 2020, or January 2021.
- c. Draft Five Year Review D. Medina stated there was no update. M. Weegar informed the team it is under review. Based on Five-Year Reviews for other Air Force installations, a path forward has been established to address various issues in a consistent manner across all Air Force installations.
- d. FT002 RAWP Addendum and UST Removal Work Plan were both added to the Box.com on 10 December 2020, with a 30-day review period. EGLE acknowledged receipt and indicated the 30-day review period is acceptable.

Bay West / Wood

- a. SS008 and WP004 Draft Final Work Plans
 - VIAP nearby buildings and sub-slab locations photo log was provided to EGLE on 1 December 2020, no comments are required. EGLE appreciated the photolog.
 - ii. EGLE submitted comments on 28 October 2020, there were no comments on the SS008 UFP-QAPP RA-O WP/FSP, it was submitted Final. Revised RTCs for the WP004 UFP-QAPP RA-O WP/FSP were submitted 17 November 2020. EGLE will complete its review and provide concurrence or follow on comments before 25 December 2020.

- b. Van Etten Lake Proposed Plan is under Air Force legal review.
- c. Clark's Marsh Interim Proposed Plan was submitted to EGLE on 14 December 2020.
- d. B. Place asked if the read ahead DQO's will be submitted next week. P. Bond confirmed that this is correct.
- e. M. Weegar asked if Polly Synk received access to the Box.com? B. Place will follow up with her.

FPM

a. Final LF030/031 FS EGLE stated that all comments have been resolved and the document can move forward.

4. FIELD WORK UPDATE AND SCHEDULE

Bay West

- a. FT002 Carbon Change out
 - i. The 22nd GAC changeout is tentatively scheduled for 04 January 2021, pending sampling results.
- b. SS057 RAWP Implementation
 - i. The semi-annual sampling event is scheduled for April 2021, after results are received, validated, and evaluated, the fourth injection will be scheduled.
- c. FT002 RAWP Implementation
 - i. Field work is tentatively scheduled for April 2021.
- d. Annual LTM groundwater monitoring
 - The RA-O LTM Annual sampling began in May and was completed in October 2020. Bay West followed the approved 2019 Sampling Plan. 2020 IRP sites completed: FT002, LF027, LF030/031, OT016, OT024, SS005, SS006, SS008, SS021, SS072, SS071, SS057 and WP004.
- e. Annual Basewide groundwater gauging
 - i. Bay West gauged 447 locations the week of 02 November 2020. Data was provided to EGLE.
- f. 2020 base-wide plume maps are being developed based on data from groundwater gauging and sampling.

Bay West/Wood

- g. VIAP Update
 - i. S. Bashir stated Q3 sampling took place the week of 9 November 2020. Results are under review and appear to be consistent with previous events.

Aerostar

- h. Central Treatment System (CTS) Status
 - i. P. Bond stated the CTS is operating as designed, regular sampling confirms SRD requirements are being met.
 - ii. A filter press pilot study to address the solids management disposal took place the week of 7 December 2020.
- i. Mission Pump and Treatment System (MPTS) Status
 - i. P. Bond stated the MPTS is operating as designed, regular sampling confirms SRD requirements are being met.
 - ii. P. Bond stated the resin in the lead vessel was exchanged on 13 November 2020, and the lead and lag vessel positions were rotated. This was the second resin exchange since start up in December 2019, now all original resin has been replaced.
 - iii. C. Bauer asked the reason for the resin change out; it was estimated to last approximately 2 years. P. Bond explained that there is an aerobic bacteria in the water that is causing biofouling. At the Benzene wells iron bacteria is present, but the MPTS bacteria is different. A UV light has been installed to eliminate the bacteria.
- Remedial Investigation Status
 - i. UFP-QAPP is in Air Force review.
 - ii. The Clark's Marsh Proposed Plan was submitted to EGLE and the Van Etten Lake Proposed Plan is under Air Force legal review.
 - iii. The Van Etten Lake 90% remedial design is being revised to incorporate USAF comments on the 60% remedial design package.
 - iv. The Clark's Marsh 60% design is under USAF review.
 - v. A Remedial Action Work Plan is in development which will include packages for each IRA that EGLE will review.

vi. The next scoping meeting is scheduled for 12 January 2021. P. Bond stated the read ahead DQOs will be submitted the week of 21 December 2020. EGLE will provide comments to the 15 December 2020 meeting and Risk Assessment meeting next week.

5. AIR FORCE UPDATES

- a. OWAA 10 parcels
 - i. No update provided.
- b. RAB Update
 - i. The next RAB is scheduled for 20 January 2021 at 1700 EST, virtual. Air Force is drafting an Agenda. The Agenda will include more focus on legacy issues and not just PFAS topics.
- c. Oscoda Township Stormwater discharge fee is still under Air Force review. D. Medina is hopeful the review will be completed prior to the RAB.
- d. Air Force submitted a response to the revised SRD sampling plans for CTS, MPTS and FT002 on 3 December 2020.

6. EGLE RRD – SUPERFUND SECTION UPDATES

- a. Other RAB topics
 - i. B. Place stated that on 19 January 2021 MPART will hold a virtual Townhall meeting. The NOW group will be updated on 13 January 2021. A Quarterly Meeting is scheduled with the Saginaw Chippewa Tribe on 15 January 2021, and a Wurtsmith presentation will be given. B. Place requested any old presentations that could be used to be sent to her. The Air Force agreed to see what was available and provide it to B. Place prior to the call with the Tribe.
 - ii. The Air Force is interested in the contents of the access agreement between EGLE and USFS, as the Air Force prepares the MOU with USFS. Wells were installed in Clark's Marsh recently by EGLE and the access agreement was updated. B. Place agreed to provide the access agreement information.
 - iii. B. Place is following up on the MCL status for the remaining 5 PFAS compounds and whether these are considered promulgated during the Part 201 rule making process.

7. EGLE RRD - BAY CITY DISTRICT UPDATES

- b. Loud Drive no update, sampling will be scheduled in January 2021, but no date set at this time.
- c. Oscoda area sampling there was an exceedance in an AuSable Township monitoring well, there are 14 private wells in the area of the exceedance. All residents have been notified, and sampling of the 14 wells is scheduled for January 2021.

8. EGLE WRD - UPDATES

- b. Oscoda Township Wastewater Treatment Plan (WWTP) update
 - i. C. Bauer stated that EGLE is working with the consultant in Oscoda to identify PFAS sources coming into the system. M. Weegar asked if only one round of sampling was completed on the sanitary sewer manholes. M. Siler confirmed that only one round of manhole sampling has been completed. Monthly sampling is completed at the influent and effluent of the WWTP.
- c. B. Place asked if there was a timeframe for the SRD responses to Air Force comments. C. Bauer stated that there is no time frame, the permits section is completing its review.
