

**Michigan Public Service Commission
2004 Year End Summary
Telecommunications Rights-of- Way Permits
Public Act No. 48**

Pursuant to Public Act No. 48 the Michigan Public Service Commission received notification of 352 permit applications during 2004. There were 334 permits approved in 2004. And of the 352 total permit applications requested in 2004, 332 were for unilateral permits and 20 were for bilateral permits. A total of 16 permits were denied while 2 remain pending.
