I just spoke with Mark Bouvy at MSD.

When the school first heard of the water lead issue back in September, they conducted their own testing at the school... which came back with clear results. The administrators at the school closed down the fountains and have been purchasing 35-gallon water dispensers (150 gallons/week) from Culligan that are placed near the drinking fountains. They also placed water filters at the cafeteria drinking fountain and kitchen sink for use in cooking/food prep.

MSD has been on the waiting list to get tested by DEQ since mid-December. The landlord (Lurvey-White Ventures) on its own, decided to have another test done on January 14 – this time testing both the school and the dorm. The dorm test came back with the elevated lead levels in the water.

The school received word today from the landlord that they will expedite the replacements of the 62-65 faucets in the dorm beginning tomorrow (Friday) and expect to have them all replaced by the end of the weekend.

There are 167 total students at the school, 75 of which board in the dorm.

The landlord and school administration also are looking at either replacing the shower heads in the dorm, or installing in-line filters to the showers. In the meantime, resident students are using the showers at the school, which has been tested and found to be lead-free.

The parent letters were sent out yesterday, by postal service and on the schools webpage. The next scheduled Parents Meeting is February 9, when parents can come and ask questions. The letter also informed the parents that they can contact Janet Kelley at the school in the interim.

THE BOTTOM LINE: the administration and landlord of MSD got ahead of this issue back in September and taken all of the cautionary measures to ensure the health and safety of the students at the school. Instead of waiting to get their water tested by the DEQ, they got it done privately and took immediate steps to respond to the issue when it became known.
