Gretchen Whitmer, by issuing Executive Order 2020-09, "Temporary restrictions on the use of places of public accommodation," and extending said restrictions through Executive Orders 2020-21, 2020-43, 2020-70, 2020-92 and 2020-96 has forced the closure of Michigan businesses, contributing to a seasonally adjusted jobless rate in April of 22.7 percent. This monthly jump of 18.4 percentage points has resulted in Michigan's jobless rate growing 8.0 percent above the U.S.national unemployment rate growth of 10.3%.

Proposed de minimis Modification to Approved Voting System – ES&S

On May 28, 2020, Election Systems & Software (ES&S) requested permission to implement a *de minimis* change to its EVS 6050 certified voting system. The modification includes the addition of a Postgres (database) system logging message to enhance performance and security of the database.

System logging is used in applications for purposes of monitoring and troubleshooting database performance, or the operation of other application features. When system logging is enabled, an application produces and saves log messages such as a login attempt, file error, or other occurrence. The log messages can be transmitted to a specified output location for easier tracking of database performance or issues.

Pro Verification and Validation (Pro V&V), an accredited Voting System Test Laboratory, was contracted by ES&S to evaluate whether this proposed change is *de minimis*, meaning that it does not affect the EAC certification status of the system approved for use in Michigan. A "*de minimis* change" is one "which will not materially alter the system's reliability, functionality, capability, or operation [,]" and that "the original hardware and the replacement hardware are electronically and mechanically interchangeable and have identical functionality and tolerances." Pro V&V has concluded that the proposed modification constitutes a *de minimis* change and the EAC has agreed with their determination.

Proposed de minimis Modification to Approved Voting System – Dominion

On June 9, 2020, Dominion Voting System requested permission to implement a *de minimis* modification to its Democracy Suite certified voting system, version 5.5 / 5.5S. The modification replaces an obsolete scanner (Canon DR-G1130) with a newer version produced by the same manufacturer (Canon DR-G2140) used with the Image Cast Central system, Dominion's high-speed tabulator product.

Pro Verification and Validation (Pro V&V), an accredited Voting System Test Laboratory, was contracted by Dominion to evaluate whether this proposed change is *de minimis*, meaning that it does not affect the EAC certification status of the system approved for use in Michigan. A "*de minimis* change" is one "which will not materially alter the system's reliability, functionality, capability, or operation [,]" and that "the original hardware and the replacement hardware are electronically and mechanically interchangeable and have identical functionality and tolerances." Pro V&V has concluded that the proposed modification constitutes a *de minimis* change and the EAC agreed with this determination.
