MILLAGE RENEWAL**

Shall the expired previous voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in Alcona County of 1 mill (\$1.00 per thousand dollars), reduced to .9704 mills by the required millage rollbacks, be renewed at and increased up to the original voted 1 mill (\$1.00 per thousand dollars of taxable value) to offset the millage reduction and levied for four (4) years, 2010 through 2013, raising an estimated \$776,051.00 in the first year the millage is levied, for the sole purpose of providing funding to operate and maintain the Alcona County Ambulance Service?

AGING MILLAGE RENEWAL**

Shall the previous voted increases in the tax limitations imposed under Article IX, Sec. 6 of the Michigan Constitution in Alcona County, of .375 mills (\$.375 per \$1000 of taxable value), reduced to .3719 mills (\$.3719 per \$1,000 of taxable value) by the required millage rollbacks, which will expire with the December 2010 levy, be renewed at and increased up to the original voted .375 mills (\$.375 per \$1000 of taxable value) and levied for 5 years, 2011 through 2015 inclusive, for the sole purpose of providing funding to the Alcona County Commission On Aging to operate, maintain and expand programs and services and maintain the Alcona Senior Centers, raising an estimated \$291,000 in the first year the millage is levied?
