Agenda item: Consideration of whether three recall petitions submitted by Dean Schuette on October 29, 2018 factually and clearly states each reason for the recall of Jackson County Sheriff Steven Rand.

The reasons for recall printed in the heading of the *first petition*, which was filed at 11:56 a.m. on October 29, are as follows:

On August 8th 2017, Sheriff Rand accidentally discharged a hand gun in his office, causing damage to the floor and carpet. Sheriff Rand did not report the incident, and attempted to cover it up. This is a violation of Michigan Law. Section: 752.863a.

Board action on agenda item: The Board determined that the recall petition filed by Dean Schuette on October 29, 2018 at 11:56 a.m. does not factually and clearly state each reason for the recall of Jackson County Sheriff Steven Rand because it contains a statement that is not substantiated regarding an alleged “attempt[] to cover it up.” Moved by Matuzak; supported by Pero. Ayes: Shinkle, Matuzak, Pero, Bradshaw. Nays: None. Motion carried.

Agenda item: Consideration of whether the recall petition submitted by Dean Schuette on October 29, 2018 factually and clearly states each reason for the recall of Jackson County Sheriff Steven Rand.

The reasons for recall printed in the heading of the *second petition*, which was filed at 12:07 p.m. on October 29, are handwritten and printed on the attached petition.

Board action on agenda item: The Board determined that the handwritten recall petition filed by Dean Schuette on October 29, 2018 at 12:07 p.m. does not factually and clearly state each reason for the recall of Jackson County Sheriff Steven Rand because the petition language is not substantiated by sufficient evidence. Moved by Pero; supported by Bradshaw. Ayes: Shinkle, Matuzak, Pero, Bradshaw. Nays: None. Motion carried.

Agenda item: Consideration of whether the recall petition submitted by Dean Schuette on October 29, 2018 factually and clearly states each reason for the recall of Jackson County Sheriff Steven Rand.


The reasons for recall printed in the heading of the *third petition*, which was also filed at 12:07 p.m. on October 29, are typed on the attached petition.


