Committees are required to disclose expenditures made from October 20 through November 24 on the Post-General Campaign Statement, due December 4, 1980.

- . In-kind contributions, in-kind expenditures, and outstanding debts are included in the expenditure totals.
- . Loans and loan repayments are not counted as expenditures.
