

# MICHIGAN NOTARY PUBLIC

## APPLICATION and INSTRUCTIONS

The application process for becoming a Michigan Notary Public is complex. To assist, you are encouraged to review the instructions throughout this document to ensure successful and timely completion. Detailed instructions for filling out each field is available below the form. For assistance, email us at [Disclosure@Michigan.gov](mailto:Disclosure@Michigan.gov).

Step by Step:

1. Fill out the application **completely**. (Don't leave any fields blank!)
2. Obtain A \$10,000.00 [surety bond](#) written for a term of six or seven years through a Michigan licensed insurance company.
3. Take the surety bond, completed application and the appropriate fee to the [county clerk's](#) office. (The Clerk will file your bond and give you an Oath).
4. Mail the original completed application and an additional \$10.00 filing fee to this office.
5. Look for the commission card and/or email – allow 4-6 weeks for processing
6. Check the status of your appointment at on our [website](#). Bookmark this site to visit later. (Note, **Do not** perform notarial acts until you are listed as "Active" on this website or you have received your commission information!)

IMPORTANT! Double check before sending your application!

- ✓ Type out the form completely; don't leave any blanks.
- ✓ Don't forget the \$10.00 filing fee in your mailing.
- ✓ Visit the correct County Clerk's office; the one listed on the application form.

## Instructions for Applying for Appointment as a Michigan Notary Public (New, Attorney & Renewal)

**IMPORTANT: You are not a notary public until your name appears as “Active” on the State of Michigan Notary Public Search website. If renewing our notary public appointment, please do not submit the appointment form until 60 days prior to your expiration date. The appointment form must include the \$10 filing fee.**

- Only your official signature should be written, all other information should be typed.
