
Brandon Brice, MS

Brandon now serves as Director of the Boy Scouts of America's early Workforce Development Apprenticeship Programs.

Brandon has given lectures at Princeton University, the Baltimore Harbor League, the National Black Law Students Association, the American Enterprise Institute and the Hamilton Society in Washington, D.C. He is a 2018 recipient of the Michigan Chronicle's Distinguished Men of Excellence Award and the Spirit of Detroit Award in 2018. 
