Section 9(1) provides that if a report is filed late, the legal defense fund or the elected official shall pay a late filing fee. If the legal defense fund has received contributions of \$10,000.00 or less during the previous 2 years, the late filing fee shall be \$25.00 for each business day the report remains unfiled, but not to exceed \$500.00. If the legal defense fund has received contributions of more than \$10,000.00 during the previous 2 years, the late filing fee shall be determined as follows, but shall not exceed \$1,000.00: (a) Twenty-five dollars for each business day the report remains unfiled. (b) An additional \$25.00 for each business day after the first 3 business days the report remains unfiled. (c) An additional \$50.00 for each business day after the first 10 business days the report remains unfiled.


