


Honored Commissioners,

This resulted in Republicans winning 35% of the vote in 2012, but only received 13% of the seats. 2016 was slightly better, but still showed a large disparity.



2) EDS stated that they worked in the state of Virginia. Virginia had its maps struck down by the Supreme court for violating the rights of African American voters through packing the districts. What role did EDS have in making those maps?



- 3) If the Michigan Districting Commission set a goal of achieving the lowest efficiency gap, could EDS taylor a map to achieve those goals?
- 4) If set up a matrix for scoring maps was determined to be used, what performance metrics could EDS support?





My name is Alyssa and I am writing from my home in Grand Rapids, Michigan.

I am writing to address something that has been bothering me since watching the March 4th meeting where commissioners voted to use EDS as their consulting agency.

Rebecca raised a concern about EDS' moral integrity and their ability to serve the commission and Michiganders well. While I fully agree with her wariness, what concerns me most right now is not that EDS' was ultimately chosen by the commission, but rather the way the commission responded to Rebecca's comment.

First, one commissioner suggested that Rebecca's comments were out of line, and that it made this commissioner uncomfortable (e.g. heart palpitations). I would like to stress that uncomfortability is not only likely to occur regularly in this space, but that it is good. If everyone feels comfortable all the time with what's being said, to me this is evidence that the commission isn't digging deep enough into important issues such as race, which as you know is a central concern when drawing lines and an underlying reason for this commission's existence.

Second, there were comments made to the effect of 'getting back on track' or handling our emotions to move past them and onto what matters. This also concerns me. Rebecca's concerns were not only valid and logical, they were also sentiments echoed by the public in comments received. Of course the public will feel things. Commissioners should too. The redistricting process is not one void of emotions or morality; indeed, the process of redistricting is inherently these things, or else it's not being done with enough intention and attention to equity, the VRA, history, or gerrymandering and its insidious effects.

Commission, I have faith in you! Please don't be afraid to continue to "dig in" and say the hard things. And when someone says something that makes you feel uncomfortable, thank them, and then look inwards instead of outwards. Why am I feeling this way? What does it say about me or what concerns me most right now? And, don't shuffle past or hurry conversations around morality and emotions as "lesser" things. Indeed, a focus on data and facts may obscure the truth\*.

Thank You for your service, dedication and hard work.

We write to comment on the critically important public hearing phase of the community input process. We appreciate the Commission's careful consideration of where the minimum of 10 hearings in the first round of public comment will be held and applaud the interest in potentially expanding the number of hearings above 10. Should a decision be made to increase the number of hearings, we urge you to base the decision on population as has been done with the initial selection of 10 hearing locations.

We also noticed that the proposed location for the Detroit meeting in May is TCF Center in downtown Detroit. At the present, Covid-19 vaccinations are taking place at the TCF making it more difficult to navigate, especially as you arrive by car. There are also concerns of parking and other logistics that would make TCF not a conducive place to hold the meeting. In addition, having a meeting in the neighborhoods may be easier for Detroit residents without access to a car. We would suggest using an alternative venue such as one of the city's recreational centers be used. Thank you for your work and your consideration of these important issues.

To the members of Michigan's Independent Citizens Redistricting Commission:

Since the 2018 election, Voters Not Politicians has dedicated itself to defending the redistricting reform amendment in court and supporting community mapping so that Michigan will finally have fair district maps and unrigged elections where every vote counts. VNP is facilitating conversations, conducting hands-on training workshops, and producing resources to make sure underserved and disenfranchised communities in particular, which are not usually part of the redistricting conversation, have the support they need to give input and actively engage with the Commission.

The voter-centered redistricting reform amendment provides time for robust public engagement by the Commission before Census data is released, and continued engagement around maps drawn with Census data. The Census Bureau's recent announcement that 2020 Census data will be further delayed, perhaps until September 30, 2021, is not ideal. But we see it as an opportunity for the Commission to hold extensive hearings to take public testimony about where communities of interest exist. The only adjustment needed is on the other side, when the Commission engages the public around maps drawn with 2020 Census data. After consulting with national and state redistricting experts, we would like to offer an adjusted timeline for your consideration.

We would propose that the Commission take appropriate legal action to seek a limited extension of the constitutional deadline for approving final plans from November 1 (current) to December 20, 2021. Relatedly, the deadline for the Commission to release for public comment the proposed state House, state Senate, and U.S. Congressional districts they will vote on should be extended from September 17 (current) to November 5, 2021.

These adjustments would give the Commission 5 weeks to draw maps with 2020 Census data and hold a minimum of 5 hearings for public input, which is an adequate amount of time if it has prepared by using all of the data and products available up to that point. By moving the start of the public comment period to November 5, the public still would have 45 days for public comment before the Commission's final vote on December 20, 2021. We strongly recommend that the Commission NOT vote on district maps drawn without the new Census data. Final approval on December 20, 2021, means the maps would become law on February 18, 2022, which still gives candidates a full 60 days to file before the April 19, 2022, statutory deadline; which we believe to be a sufficient amount of time. Please see the attached chart for a side-by-side comparison of the current and proposed timelines.

We understand that some people are urging the Commission to delay the new maps even beyond December 20, using the Census' delay as an excuse. We submit that any further delay would betray the 61% of Michigan voters who voted for Proposal 2 and are counting on the Commission to approve new maps as soon as possible.

Voters Not Politicians volunteers and staff also offer the following recommendations to improve the accessibility of the proposed public hearing schedule currently being developed by the Commission.

- Kalamazoo/Battle Creek: Given the extended period before 2020 Census data is available, the Commission will be able to hold more public hearings. An estimated 396,000 residents live in Kalamazoo and Calhoun counties. Adding a public hearing in the City of Battle Creek or Kalamazoo would directly serve those communities and increase access to numerous rural communities in the area such as Branch, St. Joseph, Van Buren, Hillsdale, and Barry counties.
- **Remote testimony**: Allow live public testimony at every public hearing via Zoom or other remote video conferencing tool.
- Night & Weekend accessibility: If two hearings are held in a city, the commission should strongly consider hosting at least one of them in the evening (between 4-8 PM) and/or on the weekend to accommodate residents with daytime responsibilities.
- Services for non-english speakers: Translate meeting materials and content into multiple languages, particularly in communities such as Dearborn, Muskegon, Grand Rapids,
   Detroit and Warren with a substantial number of non-English speaking residents.

Thank you for contributing your time and talents to this historic endeavor. We deeply appreciate your commitment to ensuring all Michiganders have ample opportunity to make their voices heard during the redistricting process.
