I am a born and raised Michigander from the tiny town of Columbiaville. I joined the military right out of high school, married a girl in Japan 20 years ago, and now have 3 boys. I used my GI bill and military retirement to earn my Master's in Public Administration though have worked mostly in the automotive industry. I am a proud American and a very left leaning liberal. I have never worked for a political party in any way.

I told you about my background because I am concerned about what has happened at other redistricting commissions. There the political partiessent people to go to the public meetings and present themselves as honest concerned citizens to promote policies that would benefit their party. 
