Juanita F. Bocanegra Candidate for District Court Judge, 58th District Regular Term, Non-Incumbent Position

CHALLENGE: A challenge was filed by Vernon Helder alleging that every petition sheet filed by Ms. Bocanegra is invalid because "none of the petitions contains the words 'judge' [which] leaves ambiguity as to the exact position being sought by the candidate." The heading printed on petition sheets reads,

¹ Pursuant to MCL 168.544f, candidates seeking this office must submit a minimum of 1,000 valid signatures to qualify for placement on the ballot. Ms. Bocanegra qualifies for a 50% reduction in the number of required signatures consistent with the April 20, 2020 order of the federal District Court for the Eastern District of Michigan in *Esshaki v Whitmer*, <u>https://www.michigan.gov/documents/sos/23_order_granting_PI_687756_7.pdf</u>.

Although staff recommends the disqualification of other judicial candidates with heading issues currently pending before the Board,² here, Ms. Bocanegra's nominating petition clearly informs voters that she is a candidate for election to the 58th District Court. There are not multiple different categories of positions to be elected to this court in 2020; only one regular term non-incumbent position is available.

Additionally, there are no other elective offices associated with the 58th District Court recognized under Michigan law, aside from Judge. For example, the positions of district court administrator and magistrate are not elective offices which could be confused with the position sought by Ms. Bocanegra.

STAFF RECOMMENDATION: Determine petition sufficient.
