Dear Superintendent Wilmot:

The Department of State (Department) has completed its initial investigation of the complaint filed against you by Kenneth Short, which alleged that you violated section 57 of the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.257. This letter concerns the disposition of Mr. Short's complaint.

The MCFA prohibits a public body or an individual acting on its behalf from "us[ing] or authoriz[ing] the use of funds, personnel, office space, computer hardware or software, property, stationery, postage, vehicles, equipment, supplies, or other public resources to make a contribution or expenditure." MCL 169.257(1). Expenditure is a term of art which includes "a payment, donation, loan, or promise of payment of money or anything of ascertainable monetary value for goods, materials, services, or facilities in assistance of, or in opposition to . . . the qualification, passage, or defeat of a ballot question [.]" MCL 169.206(1). A knowing violation of section 57 is a misdemeanor offense. MCL 169.257(3).

The Act also requires the Department to "endeavor to correct the violation or prevent a further violation by using informal methods [.]" if it finds that there may be reason to believe that a violation has occurred, and if the Department is unable to correct or prevent additional violations, it must ask the Attorney General to prosecute if a crime has been committed. MCL 169.215(10)(a). The objective of an informal resolution is "to correct the violation or prevent a further violation [.]" *Id.*

Mr. Short filed his complaint on February 4, 2013. You filed an answer on February 22, 2013, and Mr. Short filed a rebuttal statement on March 6, 2013.

Mr. Short alleged that you improperly used public resources to 1) establish the Our Kids First ballot question committee (the Committee), 2) establish the Alpena-Montmorency-Alcona Education Service District's (AMA ESD) administration building's address as the address of record for the Committee, 3) distribute a letter on Committee letterhead (which included the AMA ESD building address) soliciting contributions to the Committee and asking that donations to be sent to the "District Office," 4) establish a Committee website registered using the AMA ESD administration building address, 5) post a letter on the Committee's website asking teachers to contribute to the Committee by giving a check to "Tony Suszek at AMA ESD [.]" and 6) hold

a community forum at an AMA ESD building with RSVPs going to a district employee at a district telephone number or her district e-mail address.

As evidence, Mr. Short provided a copy of a letter on Committee letterhead dated November 29, 2012 which states "make your donation payable to Our Kids First and send it to the District Office. The checks will be delivered to the campaign treasurer." (Emphasis provided.) Mr. Short also provided the Committee's Statement of Organization listing the AMA ESD administration building address as the Committee's address, a printout of a page from the Committee's website with a "A Message to Area Teachers" asking teachers to "Make a contribution by check to the 'Our Kids First' committee c/o Tony Suszek at AMA ESD [,]" an advertisement paid for by the Committee which was published in the January 30, 2013 *Alcona County Review* which urges voters to vote yes at the February election, and a notice of a community forum to be held at the AMA ESD administration building which was published in the January 30, 2013 *Alcona County Review*.

In response, you stated that the AMA ESD address was used on the Committee's original Statement of Organization, but that there was never an intent "to receive correspondence at this address or to suggest that the campaign was run from that location." Additionally, you stated that "[m]erely listing the address on documents did not result in any expense to AMA ESD and did not cause any AMA ESD property, facilities, equipment or resources to be utilized." You further stated that an amended Statement of Organization was filed listing an alternative address for the Committee. You admit that the Committee's website was created by Todd Kruger, an AMA ESD employee, but you contend that it was created on Mr. Kruger's own time, on Mr. Kruger's personal equipment, and at Mr. Kruger's expense.

You admit that you wrote two letters, one to parents and grandparents and one to teachers, but assert that these letters were authored on your own personal time. You argue that you did not instruct teachers to mail their donations to Mr. Suszek and that Mr. Suszek did not receive "any donations from area teachers mailed to the AMA office." You assert that no funds were mailed to AMA ESD by area educators and "no mail clerks, secretaries or bookkeepers were utilized in the collection of such funds." You further state that "not a single fax has been sent or received related to the campaign using the AMA ESD fax number [,]" and that the AMA ESD fax number was not included on the Committee's amended Statement of Organization to "eliminate any misconception of the use of AMA ESD equipment and property." Finally, you admit that the AMA ESD did have an informational forum open to all members of the AMA ESD community. However, you further assert that there was no "Vote Yes" message delivered, no Our Kids First campaign materials were used or available, and that the AMA ESD "has held other community forums on a variety of educational matters." Finally, you assert that the published notice for the forum was properly paid for by AMA ESD and the RSVPs were "required in order to plan and set up for the number of attendees."

You provided a signed affidavit from Tony Suszek stating that he "acted as the volunteer Designated Record Keeper solely and entirely on [his] own personal time [,]" that he "did not receive any donations from area educators mailed to the address of AMA ESD 2118 US 23 South [,]" that "[n]o mail clerks, secretaries, or bookkeepers were utilized in the collection of such funds [,]" and that he "did not receive any campaign material faxed to [him] using the AMA ESD fax" number.

In his rebuttal statement, Mr. Short responded that the Committee received \$5,772 in contributions before the Committee filed an amended Statement of Organization with a new address and fax number, that neither you nor Mr. Suszek denied *receiving* contributions at the administration building (you both only denied that contributions were mailed to the administration building), that the AMA ESD “functioned as the registrant of the [Committee’s] website and Mr. Krueger used his official school district email address for related correspondence[,]” and he reiterated that you instructed teachers to take contributions to “Tony Suszek at AMA-ESD.”

The Department notes that Mr. Short has newly alleged the possibility that cash contributions were collected prior to the formation of the Committee and these cash donations were then “falsely claimed by employees of Mr. Wilmot” and then disclosed on the Committee’s pre-election campaign finance statement. No evidence has been provided to support this specific allegation, and the Department dismisses this allegation without prejudice.

The Act prohibits a school official from expending public money or using public resources to further the qualification, passage, or defeat of a ballot question. Mr. Short alleges that listing the AMA ESD address and fax number on the Committee’s Statement of Organization gives rise to an expenditure. However, the purpose of the address and fax number on the Statement of Organization is to allow the appropriate filing official to have a means to contact the Committee for filing and enforcement purposes, not to assist the passage or defeat of a ballot question. For example, the filing official may find it necessary to contact the Committee to remind it of upcoming filing deadlines, give notice of an error in a report, and so on. The mere submission of an address and fax number to the filing official does not give rise to an expenditure of public resources by the Committee as that term is defined in the MCFA. This portion of Mr. Short’s complaint is dismissed.

However, Mr. Short further alleges that the use of the AMA ESD address in the letterhead and website also gives rise to a prohibited expenditure. The purpose of providing the AMA ESD address on campaign materials is essentially to invite readers to contact the Committee for campaign purposes and to further the qualification or passage of the ballot question. Any contact with the Committee at the AMA ESD administration building or through the AMA ESD fax number would give rise to a prohibited expenditure.

The Department believes that the evidence may support a conclusion that contributions were received and processed by Mr. Suszek during working hours at the AMA ESD administration building. While you deny in your answer, and Mr. Suszek denies in his affidavit, that any contributions were *mailed* to the AMA ESD address provided on the letterhead and on the Committee’s Statement of Organization, neither one of you addressed the allegation that Mr. Suszek did, indeed, receive and process contributions at the AMA ESD administration building, utilizing Mr. Suszek’s taxpayer-funded time and taxpayer-funded resources. It has long been the position of the Department that receiving and processing contributions using public resources gives rise to an expenditure in violation of the MCFA.

In the letter dated November 29, 2012, Bob Petrovich instructed recipients to “make your donation payable to Our Kids First and send it to the District Office.” Your letter to area teachers instructed teachers that they could “[m]ake a contribution by check to the “Our Kids First” committee c/o Tony Suszek at AMA ESD.” The letter further indicated that the “checks

will be delivered to the campaign treasurer.” Please respond in writing to the following questions, and provide documentation that supports your explanation: how many contributions were collected by Mr. Suszek, or any other AMA ESD employee, at any AMA ESD building; what was the amount of time during working hours that Mr. Suszek, or any other AMA ESD employee, spent collecting and documenting these contributions; and which AMA ESD resources, such as, but not limited to, paper, paperclips, envelopes, computer software or hardware, pencils, pens, etc., were used to document or process these contributions and what was the cost of these resources.

Additionally, the Department believes that the evidence may support a conclusion that the Committee expended public resources with regard to the Committee’s website. While you contend that Mr. Kruger created and maintained the Committee’s website on his own time using his own resources, the registration information provided by Mr. Short from godaddy.com indicates that Mr. Kruger registered the website with godaddy.com under “AMAESD” and used his AMA ESD e-mail address as the contact address for the website. It is not only reasonable to conclude that at a minimum Mr. Kruger’s email address was used for Committee correspondence with godaddy.com, but also that Mr. Kruger may have used AMA ESD time and resources to establish and maintain the website. Otherwise, it is reasonable to conclude that Mr. Kruger would have used his personal email address and the Committee name for the contact information. Please provide documentation of the time and resources used by Mr. Kruger to create and maintain the Committee’s website, including the number of hours Mr. Kruger spent during work time and the number of emails sent and received regarding the website at Mr. Kruger’s AMA ESD email address.

Mr. Short also alleged that the AMA ESD violated section 57 by holding a meeting regarding the millage question at the AMA ESD building and placing an ad in the newspaper paid for by the AMA ESD. You argue that this “was an informational forum open to all members of the AMA ESD community.” You state that there was a “panel discussion held by the area superintendents and questions were fielded from those in attendance.” Finally, you add that “no Our Kids First campaign materials [were] used or available” and that “no ‘Vote YES’ message [was] delivered.”

Section 57(1)(b) provides that section 57(1) does not apply to “[t]he production or dissemination of factual information concerning issues relevant to the function of the public body.” MCL 169.257(1)(b). The Department has explained that this exception applies when there is no express advocacy<sup>1</sup> contained in the communicated information. You have stated that attendees were not urged to take any specific action regarding the millage, and there is no evidence that contradicts your contention. Therefore, the Department dismisses this portion of Mr. Short’s complaint.

Mr. Short alleges that your letters urging parents, grandparents and teachers to support the millage violate the Act. Though these letters written by you to parents, grandparents, and

teachers do urge the readers to support the AMA ESD millage, one of the narrow exceptions to section 57(1) applies to the circumstances here. Section 57(1)(f) states that section 57(1) does not apply to:


An elected or appointed official or an employee of a public body who, when not acting for a public body but is on his or her own personal time, is expressing his or her own personal views, is expending his or her own personal funds, or is providing his or her own personal volunteer services.

MCL 169.257(1)(f). Even if these letters fall under the umbrella of the MCFA (which the Department believes they do), no violation of section 57(1) occurred regarding the composition and distribution of the two letters because you composed the letter on your own time and used your own or the Committee's resources – not public resources – to distribute or publish the letters, and this activity falls within the exception contained in section 57(1)(f). For these reasons, this portion of Mr. Short's complaint is dismissed.

Finally, in your written response to the Department, please also address the new allegation in Mr. Short's rebuttal statement that the AMA ESD website contained a link to the Committee's website, which urged visitors to vote yes on the millage, and provide documentation that supports your explanation.

Kindly send your response and requested additional documentation regarding these activities to the Department by June 27, 2013. After its review of this additional information, the Department will determine how to proceed with enforcement.

**CONCILIATION AGREEMENT**

Pursuant MCL §169.215(10) of the Michigan Campaign Finance Act (the Act), MCL §169.201 *et seq.*, the Secretary of State and Brian Wilmot, Anthony Suszek, and the Alpena-Montmorency-Alcona Educational Service District (Respondents) hereby enter into a conciliation agreement with respect to certain acts, omissions, methods, or practices prohibited by the Act.

The Secretary of State alleges that there may be reason to believe that Respondents violated MCL §169.257(1) by making improper expenditures by using public funds to expressly advocate for the passage of a ballot proposal.

Therefore, Respondents hereby voluntarily enter into this conciliation agreement and assure the Secretary of State that Respondents will comply with the Act and the Rules promulgated to implement the Act.

By executing this conciliation agreement, Respondents certify that \$220.38 has been reimbursed to the Alpena-Montmorency-Alcona Educational Service District from non-public sources, which may include by way of example and not limitation, funds obtained from



individuals, community organizations, or a ballot question committee. The Respondents also agree to provide information about the need for compliance with the Act to their colleagues (School Business Officials and Superintendents) through their associations (MAISA, MASA, and MSBO) and in regional meetings.

The Secretary of State and Respondents further agree that this agreement is in effect and enforceable for four years from the date it is signed by the Secretary of State or her duly authorized representative.

The Secretary of State and Respondents further agree that this agreement, unless violated, shall constitute a complete bar to any further action by the Secretary of State with respect to the alleged violation that resulted in the execution of this agreement.

The Secretary of State and Respondents further agree that the complaint and investigation that resulted in this agreement are disposed of and will not be the basis for further proceedings, except pursuant to this agreement.

The Secretary of State and Respondents further agree that this agreement will not prevent the Secretary of State from taking action for violations of this agreement.


The Secretary of State and Respondents further agree that the Respondents' performance under this agreement shall be given due consideration in any subsequent proceedings.

The Secretary of State and Respondents finally agree that the signatories below are authorized to enter into and bind the parties to this agreement, and have done so by signing this agreement on the date below.


