It was moved by Morris, supported by Kutschman, and unanimously approved to adopt the minutes of February 13, 2018. (Item 1 on agenda)

Public Comment – Agenda Items 3-15 Only (Item 2 on agenda): No member of the public wished to speak at public comment on agenda items 3-15.

It was moved by Kutschman, supported by Morris, and unanimously approved Bulletin 3 of 2018 Millage Rollback. (Item 3 on agenda)

It was moved by Morris, supported by Kutschman, and unanimously approved Bulletin 4 of 2018 Computerized Database System Assessment Roll. (Item 4 on agenda)

It was moved by Kutschman, supported by Morris, and unanimously approved the 2018 Values for DNR PILT Properties. (Item 5 on agenda)

It was moved by Morris, supported by Kutschman, and unanimously approved to adopt the staff recommendation regarding the 2018 Cap Rates for Railroads and Carlines for State Assessed Property. (Item 6 on agenda)

It was moved by Kutschman, supported by Morris, and unanimously approved to adopt the staff recommendation to rescind the Recommended Classification Codes adopted on April 21, 2011 and approved for use by assessors the revised Recommended Classification Codes. (Item 7 on agenda)

It was moved by Morris, supported by Kutschman, and unanimously approved to receive and review the revised Form 603 (L-4018R) – State Tax Commission Analysis for Equalized Valuation of Real Property and place this item on the State Tax Commission’s May 14, 2018 meeting agenda for formal approval. (Item 8 on agenda)

It was moved by Kutschman, supported by Morris, and unanimously approved to adopt the official order to assume jurisdiction of the 2018 Assessment Roll for Hematite Township, Iron County for failure to correct all of the deficiencies after a second follow-up AMAR Review and ordered Hematite Township to hire an outside party to fix the deficiencies noted in the roll and complete the work for the 2019 assessment roll. It was moved by Morris, supported by Kutschman, and unanimously approved the official order to overturn the Sparta Township, Kent County March Board of Review and grant the disabled veteran’s exemption for the 2018 tax year for parcels 05-22-204-002 and 41-05-23-355-011 and order Sparta Township to process the exemptions for the two qualifying parcels and cancel any 2018 taxes associated with the parcels.
