**SUBJECT: FINAL 2013 STATE AVERAGE TAX RATE**

The calculation is based on the 2012 property taxes levied on Commercial, Industrial, and Utility (CIU) classifications of property.

<b>Total 2012 Taxable Valuation*</b>	<b>\$92,245,881,249.00</b>
State Education Tax Levy*	\$ 480,918,289.62
County Tax Levies	\$ 613,501,622.95
Township/City Tax Levies	\$1,147,321,689.74
School Tax Levies	\$2,300,460,381.03
Village Tax Levies	<u>\$ 27,829,136.74</u>
<b>Total 2012 Tax Levies</b>	<b>\$4,570,031,120.08</b>
<b>2013 State Average Tax Rate</b>	<b>49.54</b>

\$4,570,031,120.08 divided by \$92,245,881,249.00 equals the final State Average Tax Rate of 49.54 (\$49.54 per \$1,000 taxable value).

\*Renaissance Zone property, as part of the ad valorem tax roll, is included in the total taxable valuation. These properties do not pay State Education Tax or operating millage.  
Total 2012 Renaissance Zone CIU taxable value: \$1,946,056,421

\*Beginning with the 2008 tax year, industrial personal property is exempt from State Education Tax.  
Total 2012 Industrial Personal taxable value: \$11,179,340,019
