**DETROIT FINANCIAL REVIEW COMMISSION**

**CITY RESOLUTION 2016-13**

**CERTIFYING THE CITY OF DETROIT'S COMPLIANCE WITH THE  
MICHIGAN FINANCIAL REVIEW COMMISSION ACT**

WHEREAS, Public Act 181 of 2014, the Michigan Financial Review Commission Act (the "Act"), allows for the creation of the Detroit Financial Review Commission (the "Commission") within the Michigan Department of Treasury; and

WHEREAS, Section 6(1) of the Act empowers the Commission to provide oversight for the City of Detroit (the "City") beginning on the Effective Date of the Plan of Adjustment; and

WHEREAS, Section 6(2) of the Act requires the Commission to ensure that the City is complying with the terms and conditions of the Act and of the plan for adjustment, if applicable; and

WHEREAS, Section 6(2) of the Act further requires the Commission, except as otherwise provided in Section 8 of the Act, to certify by October 1 each year that the City is in substantial compliance with the provisions of the Act; and

WHEREAS, at the Commission meeting on September 16, 2016, documentation of the City's compliance with the Act from September 23, 2015 through August 31, 2016, attached as **Exhibit A** to this Resolution, was presented for consideration.

NOW THEREFORE, be it resolved by the Detroit Financial Review Commission as follows:

1. That the Commission hereby certifies that the City is in substantial compliance with the provisions of the Act for the period from September 23, 2015 through August 31, 2016.
2. That the minutes of the Detroit Financial Review Commission meeting at which this Resolution is adopted take notice of the adoption of this Resolution.
3. This Resolution shall have immediate effect.

1. AUTHORITY

1.1. State of Michigan Public Act 181 of 2014 ("PA 181"), Section 6(3) states the commission shall ensure that, where applicable, a qualified city or qualified school district complies with the provisions of all of the following, as applicable, and may request verification of compliance: (a) Section 8 of the publicly funded health insurance contribution act; (b) Sections 4i, 4p, 4s, and 4t of the home rule city act; (c) The revised municipal finance act; (d) The uniform budgeting and accounting act.

2. PURPOSE

2.1. The Financial Review Commission has requested the Chief Financial Officer of the City of Detroit to verify compliance with the provisions in PA 181, Section 6(3).

3. OBJECTIVE

3.1. To affirm that, to the best of my knowledge, the statements in Section 4 of this Memorandum are true and accurate.

4. STATEMENT

4.1. The City of Detroit is in compliance with Section 8 of the publicly funded health insurance contribution act, 2011 PA 152, MCL 15.568.

4.2. The City of Detroit is in compliance with Sections 4i, 4p, and 4s of the home rule city act, 1909 PA 279, MCL 117.4i, 117.4p, and 117.4s.


4.3. The City of Detroit is in compliance with Section 4t of the home rule city act, 1909 PA 279, MCL 117.4t, notwithstanding Section 4t(1)(g). The City of Detroit is implementing this provision.

4.4. The City of Detroit is in compliance with the revised municipal finance act, 2001 PA 34, MCL 141.2101 to 141.2821.

4.5. The City of Detroit is in compliance with the uniform budgeting and accounting act, 1968 PA 2, MCL 141.421 to 141.440a.
