Could you please restate 5 the question? 6 CHAIRPERSON HEADEN: Yes, this is with 7 regards to Resolution 006 to discontinue water 8 billings. The initial question I had was what 9 impact, if any, would this have on the cash flow 10 of the water supply fund if it were adopted? 11 MS. LUNDQUIST: So regardless -- can 12 you hear me? CHAIRPERSON HEADEN: 13 Yes. 14 MEMBER FINNEY: We can hear you. 15 MS. LUNDQUIST: Well, regardless of 16 the impact on the cash flow I'd first like to 17 address that the Resolution in itself would 18 violate State Law and the Revenue Bond Act. So. 19 should the law not have applied to the 20 Resolution, and without respect to the \$30 21 million relief program that the City is actively 22 working to administer and the complications that 23 would ensue from the Resolution in trying to do 24 both, administer the relief program and discontinue billing, we would be out of money 25

| 8 | an outstanding debt in the form of revenue bonds |
| 9 | for a fund, in this case the Water Fund, it is |
| 10 | obligated to set rates and administer billing |
| 11 | such that it is covering the cost of not only |
| 12 | operating and maintenance, but the payment of the |
| 13 | principal and interest on those bonds such that |
| 14 | then the the bond covenants are satisfied. |
| 15 | CHAIRPERSON HEADEN: And again, can |
| 16 | someone from the Council speak to this issue? |
| 17 | This Resolution was adopted 6 to 1 with two |
| 18 | abstentions, and I'd like to understand sort of |
| 19 | what the thinking was of the City Council behind |
| 20 | this resolution. |
| 21 | COUNCIL PRESIDENT NELSON: Thank |
| 22 | you to the RTAB. I guess what the Council was |
| 23 | saying, because of the numerous phone calls |
| 24 | that we were receiving saying that the water |
| 25 | was no good to do anything but to flush, which |
| | |

I do agree, that paying for a water bill was 1 2 just unheard for. And we know some relief was 3 coming, but because of the numerous calls that 4 we receiving from the people that we represent, 5 we felt like we had to do something. 6 At that time Attorney Chubb said he 7 would check and see if it was in violation or 8 not. 9 And at the time of -- when this 10 resolution was brought forth, it was so many calls coming in from every direction. 11 Talking to 12 other colleagues, they were receiving calls; you 13 go to block clubs, it dominated the conversation, that the water was just no good and we're 14 15 receiving all of these high water bills. 16 And so the Council said we wanted to 17 do something. And at that time Attorney Chubb 18 did, like I said before, said he would have to 19 look into it and see if he could, you know, do 20 that. 21 But as representing the people of the 22 City of Flint from various Wards 1 through 9, we 23 felt we had to step up and do something, whether 24 it was a violation or not, we didn't know at that time, but we still feel, and I do, that we still 25

need more relief. And, yes, the Governor has 1 2 sent some and he's trying to send some more that 3 I'm aware of, but the people need some help right away, and they wanted somebody to take a stand 4 5 for them and say something for them. And so that 6 way the Council put something together in saying 7 that we feel that the people that we represent 8 should not have to pay for their water services 9 at this time. All right? Any questions for me? 10 CHAIRPERSON HEADEN: The only other 11 12 question I would have with regards to the 13 resolution is that it has no end date. So was there any consideration given to how long the 14 15 discontinuation would occur; would it be six 16 months, would it be a year, would it be --17 COUNCIL PRESIDENT NELSON: We have --18 some colleagues had said 6 months, some had said 19 12. We did not come to a number term. We're not 20 going no longer than 12 months. Some had said 6 21 months, some had said 12. 22 Personally I would rather -- you know, 23 my opinion was 12. 12 months, one year. Some 24 said let's do 6 months. But it all depended upon 25 -- Attorney Chubb had said he had to do his

research whether we could -- you know, at this 1 2 point because there's a law that says we cannot, we can't even do three days, but we wanted to do 3 something to stand up for the people that we 4 5 represent and say something. 6 CHAIRPERSON HEADEN: Other questions? 7 Mr. Ferguson? MEMBER FERGUSON: I think --8 9 CHAIRPERSON HEADEN: It's on. 10 MEMBER FERGUSON: Okay. I think if it's ever possible to do this, it should be for 11 12 whatever the duration -- whatever the length of 13 time the people weren't able to use their water. 14 COUNCIL PRESIDENT NELSON: Right. 15 MEMBER FERGUSON: It should be a 16 corresponding time. So if it's been a year, or a 17 year and a half, or six months --18 COUNCIL PRESIDENT NELSON: That would 19 be two and a half years. 20 MEMBER FERGUSON: Whatever that is where people weren't getting their value for what 21 they were writing the checks for, then anything 22 23 that we could figure out should be for -- they 24 get the relief for what -- when they paid for 25 nothing --

said is correct. 1 2 The Revenue Bond Act in both, I 3 believe it's Section 17 and Section 21, in different places both require you to charge 4 5 more -- or what it costs at the very minimum to 6 produce the water when you sell the water, and 7 then additionally has a separate provision that 8 prohibits giving away water for free to anyone. 9 So either of those -- you know, I just 10 said -- everybody feels the same, and I'm a Flint 11 water customer and I don't like paying for the 12 water either, obviously, but it's just a chicken 13 before the egg thing. And so as Jody and I work 14 virtually daily with the State in implementing 15 the \$30 million credit, you know, that's when 16 people will get that allowance and that's when we 17 will be able to legally draw back the billings. 18 MEMBER FINNEY: So, Mr. Chair, given 19 the input that we've now received from the 20 Finance Director, the Attorney and from the 21 Council President, I would move to table this 22 item and refer it back to the Administration for 23 their final review before it comes back to us for 24 consideration. 25 CHAIRPERSON HEADEN: Motion has been

1 made. Is there support? 2 MEMBER FERGUSON: Support. 3 CHAIRPERSON HEADEN: Discussion? 4 Those in favor of tabling this particular item, 5 please say "Aye." (All ayes.) 6 7 CHAIRPERSON HEADEN: Opposed? Motion 8 is adopted and the item is tabled to refer back 9 to the Administration and City Council. 10 Mr. Ferguson? 11 MEMBER FERGUSON: I -- listening to 12 what's being said, it was really a symbolic -- it 13 was a communication by the City Council to tell 14 the people of Flint that they hear them. 15 I think what they've done is they've 16 made an announcement and some kind of way we've 17 got to kick the can and find a way for 18 legislature or someone else to where we can bring 19 a source in to bring relief for this action that they requested have done. Because they can pass 20 21 all of the resolutions they want going forward, 22 but if we can't find the money, it's really -- it 23 doesn't mean anything. So it's kind of kick the 24 can where we can communicate to the legislature 25 or someone else if we can get a fund or someone

to help relieve this pain that we have on this matter.

3 MEMBER FINNEY: Mr. Chairman, I would 4 just suggest that there -- what my fellow Board 5 member just suggested is outside of our purview. 6 I honestly think that the Administration should 7 continue working with the State on funding 8 opportunities, and I think that is an active 9 effort that's underway. We all know that \$30 10 million has already been committed to begin solving the water problem and I know that the 11 12 Finance Director and the Attorney just indicated 13 they're working on it. 14 So I would rather us not try to get in 15 the middle of whether the State or any other 16 source should provide additional funding. Ι 17 think that the City Administration should take 18 the lead in doing that, and then bring back to 19 us, as an RTAB, whatever resolutions are 20 appropriate and legal for our consideration at 21 some future date. 22 CHAIRPERSON HEADEN: Thank you both 23 géntlemen. 24 Next item is Resolutions from the 25 regular City Council meeting of February 22nd.

The Resolution numbers are listed there again, 1 16 2 and 17 was struck having been approved previously and Resolution 28 was added to the list. 3 Are there questions about any of the 4 5 Resolutions listed there; and if not, I'll entertain a motion that those resolutions be 6 7 approved. 8 MEMBER FERGUSON: So approved. 9 MEMBER FINNEY: Support. 10 CHAIRPERSON HEADEN: Any discussion? 11 Those in favor, please say "Aye." 12 (All ayes.) 13 CHAIRPERSON HEADEN: Opposed? Motion 14 is adopted, Resolutions from February 22nd are 15 approved. 16 Next item, City Administrator items, 17 Budget to Actual. Ms. Lundquist? 18 MS. LUNDQUIST: I apologize that what 19 I'm about to ask is outside of the agenda that I 20 know that has been adopted. There were two 21 resolutions that were passed by Council at their 22 meeting this past Monday, March 14th, that are of 23 some urgency. The one regarding the termination 24 of City Administrator Natasha Henderson, I would 25 ask that the City Council speak on should you

have any questions.

1

2 And the second is a budget amendment 3 that is predicated on the termination of the City 4 Administrator. It is a budget amendment that 5 then authorizes the transfer from the City 6 Administrator's department to the Mayor's 7 department in order to create the chief of staff 8 position and the appointment that has been made 9 to Steven Branch. Again, I did not realize that these 10 were not requested to be added to the agenda 11 12 sooner, so there aren't copies for everyone. 13 I'll pass them to you now for your consideration. CHAIRPERSON HEADEN: I'm reluctant to 14 15 have us consider these now because in fact we've 16 not seen these previously. And so I think we 17 need an opportunity, at least as a Board, to 18 review these content. We were in contact with 19 the City beginning, I believe, yesterday morning 20 to try to ascertain what business, if any, was 21 conducted by the City Council Monday night, and 22 as of at least 11:00 this morning, we had received no information. 23 24 So, we would have been prepared had we 25 gotten the information sooner to add it to the

agenda, if necessary, but I think all things 1 2 considered it would be unfair to ask us to review 3 and vote upon this now. We certainly are willing to consider this once we've had a chance to 4 review it. 5 6 MS. LUNDQUIST: I thank you for your 7 consideration, and again, I would -- those 8 communications are normally directed through the 9 Mayor's office, so I did not -- I was not aware 10 that they had any correspondence or that those 11 had not been added, but for the sake of the City 12 business and moving these items forward in 13 addition to bringing them to your attention today. 14 15 CHAIRPERSON HEADEN: I appreciate 16 that. 17 ATTORNEY CHUBB: And gentlemen, if I 18 may, if we need to take a recess or if I could 19 perhaps explain to you the resolutions in 20 question. We haven't asked for the entire agenda 21 to be approved, but these are two that are 22 extremely time-sensitive. And if you did attempt 23 to call my office, I'm very sorry if I was not 24 able to get with you. 25 CHAIRPERSON HEADEN: No, we did not

I understand. 13 ATTORNEY CHUBB: 14 CHAIRPERSON HEADEN: So there was no 15 misunderstanding there. And I appreciate the 16 explanations to the content of these, but again, 17 I think as far as our due diligence goes, we need 18 an opportunity to review these. If necessary, 19 from a timing standpoint, we can certainly call a 20 special meeting, but I think we need to have an 21 opportunity to review these. 22 There is also a related issue of 23 whether or not the employment contract provision 24 could legally impose an obligation upon the RTAB to be involved in this that we need to have 25

'16 budget. There was not adequate funding in 1 2 the Mayor's budget for a position, again, as it 3 had not been in existence at the time the budget was created. So this would transfer monies from 4 5 the City Administrator's budget to the Mayor's 6 office so that both the new City Administrator 7 and the Chief of Staff wages and pensions could 8 be funded. 9 MEMBER FERGUSON: You've kind of 10 explained this. If we recess and read this, I 11 mean, that's the only problem we have on this? 12 I -- I just --13 CHAIRPERSON HEADEN: No, I think the 14 problem is that -- the problem would be the same 15 as if we were presenting something to the City 16 Council at a meeting expecting them to pass upon 17 it without having had any opportunity to review 18 the contents of it. I think they would be quite 19 right in their position of saying that they would 20 take the opportunity to review it, through their 21 normal process, and then dispose of it once they 22 had a chance to do so. 23 We were originally supposed to meet 24 last Wednesday, as I recall, and we delayed the 25 meeting until today, because we were advised that

the City Council might take an action on the 1 2 14th. 3 And so rather than meet for consecutive weeks, we decided to accommodate the 4 5 City and the City Council by delaying our meeting 6 until today. And once we were aware of the fact 7 that City Council did meet on Monday night, 8 rather than simply wait to see what 9 communications came through, staff at the 10 Department of Treasury reached out to the 11 Administration to find out what, if anything, was 12 done that could be brought before this particular 13 body. As I indicated, as late as 11:00 this 14 morning we got no indication at all as to what 15 business was conducted. 16 In fact, I think I went to the City's 17 website Tuesday morning to find a copy of the 18 agenda. So I at least had some idea of what 19 business was before the City Council, but no idea 20 as to what business was actually conducted. 21 So I'm not unsympathetic, but on 22 the other hand, I don't think it's fair to the 23 RTAB to be placed in a position of saying we 24 have to act immediately, otherwise the City is 25 going to incur certain expenses, when I've

1 heard no clear explanation as to why these 2 resolutions could not have been provided to us 3 sometime yesterday, for example, within the 4 last 24 hours to give us an adequate 5 opportunity to review them. 6 Frankly, had they come in this morning 7 even before I left for this meeting, I would have 8 been more than happy to add them to the agenda 9 and try to examine them prior to the meeting. 10 But, this is not really short notification, this 11 is no notification. 12 ATTORNEY CHUBB: And unfortunately, 13 ironically enough, the communication from the 14 Mayor's office would have come through the very 15 people which we're trying to get approval to 16 So it likely would have come through the hire. 17 Chief of Staff or the City Administrator. So if 18 that provides some explanation as to why. 19 CHAIRPERSON HEADEN: It might, but I 20 mean we got the other resolutions and related 21 information for this particular meeting in due 22 course. 23 ATTORNEY CHUBB: I understand your 24 concerns, yes. 25 CHAIRPERSON HEADEN: Typically we have **QRS Court Reporting, LLC**

1 a deadline, that the staff knows, of the -- I 2 believe it's the Friday before the meeting, 3 because we have to have an opportunity to get the 4 information vetted internally and out to the RTAB 5 members for their review. And I'm always 6 sensitive to making sure I get information out to 7 my colleagues so they have an opportunity, as I 8 do, to review it before we come into a meeting. 9 ATTORNEY CHUBB: I understand your 10 concern. 11 CHAIRPERSON HEADEN: So I'm reluctant 12 to take precipitative action about this, this 13 afternoon. 14 MEMBER TOWNSEND: I feel in terms of 15 the budget adjustment, I understand those quite 16 clearly in terms of that, but I think the legal issue is more important, and the timing of 17 18 getting it here and having the State's legal 19 staff look at it because of the fact that this 20 Board can be sued for actions that we take, and 21 so from that standpoint, I think -- and the 22 nature of not necessarily the budget adjustment, 23 but the nature of the termination is something, and our mention in that contract is something 24 25 that I would not feel comfortable without at

least getting some sort of legal response from the State saying basically, you know, our action could cause this or that.

So as far as that's concerned, I think from my standpoint, again, the budget adjustment I'm not really concerned with that. Most of you know I can look at it and say "Yeah, it's good" real quick. But as far as the termination and the legal ramifications, I have a great concern.

MEMBER FERGUSON: Well, my question on that one is, we could pass something subject to the Attorney General's -- the legal approving it. We could pass this, but I just hate to have legal be a basis when we can pass something that doesn't take effect until it's been vetted legally, we send this up to whoever this legal party is that's going to say it's all right what we did, and if they don't approve it, then it doesn't happen.

But, as far as we're here today, if we believe that they have an emergency action that they hold up hiring people they need, that it will -- we can pass a resolution, in my mind, subject to legal approval, you know. And I'm just saying that that's another way of being

1 proactive, and, you know -- because I just -- I 2 know they're late, but I just don't want to, you 3 know, punish the City if we can find a way not 4 to. 1 Treasury that if the bonds are in fact 2 restructured, it will save the City approximately 3 \$2.2 million in interest over the remaining life of the bonds and will save the Water Supply Fund 4 5 another \$15.5 million over the next five years in 6 cash flow savings. 7 This proposed resolution of the RTAB 8 would recommend to the State Treasurer that that 9 EM Order Number 2 be modified or amended, to the 10 extent necessary, to allow the City to 11 restructure these bonds a second time. 12 So that's the basic content of the 13 resolution. 14 Are there any questions about RTAB 15 Proposed Resolution 2016-2? 16 MEMBER FINNEY: I'd move to support. 17 MEMBER FERGUSON: Support. 18 CHAIRPERSON HEADEN: Motion is made 19 and seconded. Any further discussion? If none, 20 those in favor of the resolution, please say 21 "Aye." 22 (All ayes.) 23 CHAIRPERSON HEADEN: Opposed? Motion 24 is adopted. 25 Next item is Public Comment. 

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF FLINT:

Sec. 1. That the provisions of Chapter 18, Taxation; Funds; Purchasing; Article I, In General; Section 18-4.1, Service Charge in Lieu of Taxes for Housing Facilities for Certain Persons, shall be amended by inserting a new subsection (r), which shall read in its entirety as follows:

THE CITY ACKNOWLEDGES (R) THAT COMMUNITIES FIRST, INC., A MICHIGAN NONPROFIT CORPORATION "SPONSOR") HAS OFFERED. (THE SUBJECT TO RECEIPT OF A MORTGAGE LOAN AND/OR ALLOCATION OF LOW **INCOME HOUSING TAX CREDITS FROM** HOUSING STATE MICHIGAN THE DEVELOPMENT AUTHORITY ("MSHDA"), TO ERECT, REHABILITATE, OWN AND HOUSING PROJECT **OPERATE** A AS **"COOLIDGE** PARK **IDENTIFIED** (THE "PROJECT") ON APARTMENTS" CERTAIN PROPERTY LOCATED IN THE CITY TO SERVE PERSONS AND FAMILIES OF LOW INCOME, AND THAT THE SPONSOR HAS OFFERED TO PAY THE CITY ON ACCOUNT OF THIS HOUSING DEVELOPMENT AN ANNUAL SERVICE CHARGE FOR PUBLIC SERVICES IN LIEU OF ALL TAXES.

THE CITY ACKNOWLEDGES THAT THE PROJECT SHALL BE AFFORDED TAX BENEFITS OF PAYING A SERVICE CHARGE IN LIEU OF TAXES (BUT NOT IN OF PAYMENT OF SPECIAL LIEU ASSESSMENTS INCLUDING, BUT NOT LIMITED TO THE STREET LIGHTING THE CITY ASSESSMENT). SPECIAL

FURTHER ACKNOWLEDGES THAT THE PROJECT FITS WITHIN THE CLASS AS DESCRIBED IN §18-4.3 BELOW. THE ANNUAL SERVICE CHARGE FOR THE CLASS OF PERSONS OF LOW INCOME SHALL BE EQUAL TO FOUR PERCENT (4%) OF THE DIFFERENCE BETWEEN THE CONTRACT RENTS ACTUALLY COLLECTED AND UTILITIES; HOWEVER, THE SERVICE CHARGE SHALL NOT EXCEED TAXES WHICH WOULD BE PAID ABSENT THIS TAX EXEMPTION.

An ordinance to amend the Code of the City of Flint by amending Chapter 18, Taxation; Funds; Purchasing; Article I, In General; Section 18-4.7, Same – Duration.

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF FLINT:

Sec. 1. That the provisions of Chapter 18, Taxation; Funds; Purchasing; Article I, In General; Section 18-4.7, Same – Duration, by amending in part and restating Section 18-4.7, which shall read in its entirety as follows:

§18-4.7 SAME – DURATION.

This ordinance, Sections §§ 18-4.1 through 18-4.7, shall remain in effect and shall not terminate so long as the Authority-aided or federally-aided mortgage loan remains outstanding and the unpaid HUD mortgage insurance is still operative or the Authority or HUD have any interest in the property; provided, that construction or renovation of a housing development commences within one year from the effective date of this ordinance. The tax incentive provided in §§ 18-4.1 through 18-4.7 shall remain in effect and shall not terminate with respect to any particular housing development so long as the Authorityaided or federally-aided mortgage loan remains outstanding and unpaid for that particular housing development or for so long as HUD or the Authority shall have any interest in the property of a particular housing development. Provided, with respect to the River Village Project. Provided further, that construction or renovation of the housing project commences on or before February 28, 2012. Provided further, that with respect to Court Street Village, construction of the housing project commences on or before October 30, 1990; and that, with respect to Avon Park, that construction of the housing project commences on or before October 30, 1994. Provided further, that with respect to Frontier Development Group, LLC/Phoenix Apartments, construction of the housing project commences on or before July 1, 2014. PROVIDED FURTHER, THAT WITH RESPECT TO THE PROJECT "COOLIDGE PARK APARTMENTS," CONSTRUCTION OF THE HOUSING PROJECT COMMENCES ON OR BEFORE AUGUST 1, 2019.

Sec. 2. This ordinance shall become effective immediately following publication.

AMENDING EMERGENCY MANAGER AMBROSE ORDER No. 3

WHEREAS, Section 23(1) of Public Act 436 of 2012, the Local Financial Stability and Choice Act (the "Act"), provides that "[b]efore removing a local government from receivership, the governor may appoint a receivership transition advisory board to monitor the affairs of the local government until the receivership is terminated"; And

WHEREAS, Section 23(2) of the Act provides that "[a] receivership transition advisory board shall consist of the state treasurer or his or her designee, the director of the department of technology, management, and budget or his or her designee, and, if the local government is a school district, the superintendent of public instruction or his or her designee. The governor also may appoint to a receivership transition advisory board 1 or more other individuals with relevant professional experience, including 1 or more residents of the local government"; And

WHEREAS, Section 23(5)(h) of the Act authorizes a receivership transition advisory board to perform, in addition to duties specified in the Act, "any other duties assigned by the governor at the time the receivership transition advisory board is appointed"; And

WHEREAS, on April 29, 2015, the Governor appointed a Receivership Transition Advisory Board for the City of Flint (the "Board"). The Governor's appointment letter authorized the Board to, among other things, "[r]ecommend amendments, modifications, repeal, or termination of Emergency Manager Order No. 20, or any other Flint Emergency Manager orders, to the State

Treasurer."

NOW THEREFORE, be it resolved by the Board as follows:

1. That it be recommended to the State Treasurer that Paragraph 21 of Flint Emergency Man-

ager Ambrose Order No. 3 be amended to read as follows:

Review current and potential litigation and labor disputes with the City Attorney and Mayor, and as needed the Board, and have complete decision-making-authority on-behalf-of-the-City, on-all-matters of litigation and labor disputes, including the ability to settle or initiate lawsuits and resolve labor disputes. The Mayor and City Council shall be consulted on such matters prior-to-implementation. CHIEF LE-GAL OFFICER, CHIEF FINANCIAL OFFICER, MAYOR, AND CITY COUN-CIL, AND WITH THE CONCURRENCE OF THE CHIEF LEGAL OFFICER, PROPOSE TO THE MAYOR, AND CITY COUNCIL CONSISTENT WITH SECTION 4-604 OF THE CITY CHARTER, THE SETTLEMENT OR INITIA-TION OF LITIGATION OR RESOLUTION OF A LABOR DISPUTE. A PRO-POSED SETTLEMENT OR INITIATION OF LITIGATION OR RESOLUTION OF A LABOR DISPUTE SHALL CONTAIN A DETAILED STATEMENT BY THE CHIEF FINANCIAL OFFICER INDICATING THE ESTIMATED FINAN-CIAL IMPACT UPON THE CITY FOR EACH FISCAL YEAR AFFECTED BY THE PROPOSED SETTLEMENT OR INITIATION OF LITIGATION OR RES-OLUTION OF A LABOR DISPUTE. A PROPOSED SETTLEMENT OR INITI-ATION OF LITIGATION OR RESOLUTION OF A LABOR DISPUTE SHALL NOT BE EFFECTIVE UNLESS APPROVED BY THE BOARD.

- That the minutes of the Board meeting at which this Resolution is adopted take notice of the adoption of this Resolution.
- 3. The State Treasurer may approve this Resolution by executing a counterpart copy separate from that approved by the Board, each of which copies when executed shall be deemed an original, but all of which when taken together shall constitute one and the same Resolution.
- 4. This Resolution shall have immediate effect.
