## Eligible Funding Amounts for Non-Entitlement Units (NEUs)

Estimates Generated by the Michigan Department of Treasury as of June 17, 2021

*The following are unofficial funding estimates under the American Rescue Plan Act for Non-Entitlement Units (NEUs). The list does not include Metropolitan Cities or Counties. These amounts reflect the maximum amount eligible. The first tranche, half of the award, will be paid in 2021. The second tranche will be paid approximately twelve months after the first tranche. Local units will need to complete an application to receive funding, which will be released in early July.*

*Estimates are based upon data provided by the U.S. Treasury. Amounts listed are preliminary and subject to change. To receive these distributions, NEUs must request the funding and comply with all federal requirements. Under the American Rescue Plan Act, all distributions to NEUs may not exceed a cap of 75 percent of the unit's budget, as prescribed by Section 603 (b)(2)(C)(iii) of the Act. The following distribution estimates do not reflect this cap. Updated amounts will be posted once budget information and acceptance is completed by the 1,724 NEUs.*
