Michigan Web Account Manager (MiWAM)

The Michigan Web Account Manager (MiWAM) is TIA-UI's online system for managing employer unemployment accounts. MiWAM makes doing business with the agency easier, faster and more efficient. In addition, online insurance accounts are secure, accurate and provide faster processing.

MiWAM allows users to perform routine transactions such as filing reports, paying taxes, viewing statements, and updating unemployment tax account information online. There is no charge to employers and the system is accessible 24 hours a day, seven days a week.

Benefit Claims

Unemployment Insurance is a program to provide temporary income to workers who have lost their job through no fault of their own. The program is funded through unemployment taxes paid by employers. Wage information is provided directly from Michigan employers. For additional questions regarding benefit claims call 1-866-500-0017.

Employer Seminars

Work Share Program

Workshare is an option for employers to reduce employee hours and keep their skilled workforce intact. The employer reduces hours and the employee collects partial unemployment benefits. The program preserves jobs and a trained workforce during economic declines by providing pro-rated benefits to workers whose hours are reduced.

Advocacy Program

The Advocacy Program offers information, consultation and representation to employers and unemployed workers for most appeal hearings at the Michigan Administrative Hearings System (MAHS) level.
