Background: The WDA was awarded DWT NEG funds specifically for the purpose of providing training services to DWs, including, but not limited to, those who are long-term unemployed and recipients of Unemployment Insurance (UI) that have been profiled as likely to exhaust their benefits. The opportunity for DWs to participate in training, and acquire an industry-recognized credential that enables them to obtain self-sufficient employment, is a priority of this grant.

Policy: This policy change recaptures and redistributes DWT NEG funds previously awarded in WDA PI 13-07, issued July 18, 2013, and WDA PI 13-07 Change 2, issued March 25, 2015. **This policy change also extends the date for full expenditure of DWT NEG funds to September 30, 2015.** If absolutely necessary, the WDA reserves the right on a case-by-case basis to extend the end date for full expenditure of funds to December 31, 2015, to coincide with the official end date of this grant.

All other provisions of the WDA PI 13-07, issued July 18, 2013, and subsequent changes, not addressed in this policy change remain unchanged and in effect.

Action: All MWAs impacted by this policy change who have not already done so are required to submit a revised Budget Information Summary to the WDA within 30 days from the issue date of this policy to Ms. Teresa Keyton at keyton@michigan.gov reflecting their revised award and/or grant end date. Please copy your designated WIOA state coordinator on the e-mail submission as well.
