Background: The PATH program is a partnership between the MWAs, the Michigan Department of Health and Human Services (MDHHS) and the WDA. Benefits of this partnership include linking employer, community and faith-based solutions with the human service, education and training systems.

Effective October 1, 2014, the WDA has entered into agreement with the MDHHS that the WDA will provide the MDHHS a listing of PATH subcontractors for each MWA and the amount of funding contracted to that provider for the fiscal year. The WDA has also agreed to provide MDHHS the work participation rate for each subcontractor at the end of the fiscal year.

Policy: On an annual basis, the MWAs will be responsible for providing the WDA with a list of their PATH subcontractors and the amount allocated to each subcontractor for the fiscal year. For FY 2015 (current fiscal year), the listing must be received by June 5, 2015. In addition, the MWAs must also provide the FY 2015 year-end Work Participation Rate (WPR) for each subcontractor. The WPR data will be due on November 13, 2015.

Action: MWA Directors must submit the listing of their current PATH subcontractors and allocations by June 5, 2015, to Vancep1@michigan.gov.
