**Background:** The federal Wagner-Peyser Act of 1933 provides for the establishment of a

nationwide labor exchange system with offices that provide job matching at

no cost to all employers and job seekers known as the ES. The

Wagner-Peyser Act was amended by the WIOA in 2014, which calls for stronger partnerships with ES to seek new avenues to enhance the seamless

delivery of services in the One-Stop system.

## ES focuses on a variety of employment-related labor exchange services including:

- Job search assistance.
- Assessments.
- Job referrals.
- Placement of job seekers.
- Re-employment services to Unemployment Insurance (UI) claimants.
- Registering UI claimants for work.
- Delivery of the UI Work Test.
- Recruitment services for employers.

Policy:

This policy change awards the MWAs an additional \$2,750,000 to continue the delivery of employment-related labor exchange services.

All other provisions of PI 18-19 not specifically altered by this policy change remain unchanged and in effect.

Action:

The MWA officials must submit a revised Budget Information Summary (BIS) using the allocations detailed in Attachment A. A template is attached to this policy for MWA use.

The BIS must be submitted electronically to the Michigan Talent Investment Agency/Workforce Development Agency (TIA/WDA) at <u>TED-TSDIV@michigan.gov</u> within 30 days of the issuance of this policy.
