Re: NOTICE OF PLANT CLOSING

Dear Ms. Johnson:

Adient USA LLC (also known as Recaro) (the "Company") plans to permanently cease operations at its Auburn Hills facility located at 4120 Luella Lane, Auburn Hills, Michigan 48326. In connection with permanently ceasing operations at the Auburn Hills facility, the Company anticipates that it will begin to decrease some operations on October 1, 2017, anticipates that it will decrease some additional operations on December 30, 2017, and ultimately anticipates that it will close the Auburn Hills facility in March 2018.

Although the Company will no longer employ any individuals at the Auburn Hills facility, the Company plans to offer comparable positions at other Company locations to many current employees whose positions are being eliminated as a result of this change in operations. More specific information regarding the opportunity to transfer to another facility will be shared with employees at a later date and may include the opportunity to perform the same or a similar job at the Company's Plymouth, Southfield, or Detroit, Michigan locations. The Company anticipates that 129 employees will be affected by the closure, either because they will be transferring to another Company location, or because they will be separating from the Company.

A list of the affected job titles and number of employees per classification is attached. The employees are not represented by a union. No bumping rights exist.

This notice is intended to comply with the notice obligations, if any, of the Company under the Worker Adjustment and Retraining Notification Act ("WARN Act"). However, the giving of this notice shall not constitute an acknowledgement by the Company of any obligations under the WARN Act in the event the effects of the plant closing described in this notice are such that the requirements of the WARN Act do not apply.
