Pursuant to the Worker Adjustment And Retraining Notification Act ("WARN"), 29 U.S.C. §2101 *et seq.* (1988), this is to inform you that ConAgra Foods, Inc. will close its facility located at 4490 44<sup>th</sup> Street SE, Grand Rapids, Michigan 49512. The planned action will affect all employees and is expected to be permanent.

The separations will occur during five phases. The first phase will occur during the fourteen-day period beginning on March 31, 2014 and ending on April 13, 2014. The second phase will occur during the fourteen-day period beginning on April 28, 2014 and ending on May 11, 2014. The third phase will occur during the fourteen-day period beginning on May 12, 2014 and ending on May 25, 2014. The fourth phase will occur during the fourteen-day period beginning on July 14, 2014 and ending on July 27, 2014. The fifth phase will occur during the fourteen-day period beginning on February 1, 2015 and ending on February 14, 2015. All separations will take place during the fourteen-day period of one of these five phases. Individual employees will be notified regarding the phase in which their termination will occur.

There are no applicable bumping rights. The affected employees at this facility are not represented by any union.
