## Dear Ms. Johnson:

In accordance with the provisions of the Worker Adjustment and Retraining Notification Act (the "WARN Act"), 29 USC § 2101 et seq., you are hereby being notified that The Detroit Medical Center (the "DMC") is in the process of transferring its housekeeping functions to an outside vendor in order to maintain efficient and reliable hospital operations. This transfer has not been finalized and is subject to certain events and conditions being satisfied. The selected vendor will carry out housekeeping functions at the affected locations. As such, this letter informs you that this transfer will result in a workforce reduction and directly impact employees at the following sites:
