Re: NOTICE OF FACILITY CLOSING PURSUANT TO THE WORKER ADJUSTMENT AND RETRAINING NOTIFICATION ACT OF 1988(the "WARN" Act), 29 U.S.C. 2902

To Whom It May Concern:

This is to inform you that effective **November 4, 2018,** Kenco, Inc. will be permanently closing and ceasing all operations at its Country-Market store located at 7001 Dexter/Ann Arbor Rd, Dexter MI.48130, due to current and expected future losses. The affected 49 employees are a combination of FT, PT and seasonal associates (including 13 FT, 14 averaging less than 20 hours weekly and 8 being employed within last six months). The first expected date of reduction in hours associated with store's closing will be October 29, 2018, or within 7 days thereafter. The entire facility will be permanently closed to public on November 4, 2018. No bumping rights exist. However, it is our intention as events develop to offer employees the opportunity to apply for positions in our other locations. Please note, we cannot assure every associate seniority within new location or guarantee their acceptance.
