Dear Mr. Marcotte:

This is to advise you, in accordance with the requirements of the Federal Worker Adjustment and Retraining Notification Act, of the planned cessation of operations at the TreeHouse Private Brands plant located at 150 McCamly Street South, Battle Creek, Michigan. This closure will be permanent and will constitute an entire plant closure. The closing of the Battle Creek facility will commence on June 30, 2019, and the first day of employment loss will be June 30, 2019.

As a result of this closing, a list of those job classifications and the number of persons in each position who will be separated from employment is included on page 2. No bumping rights exist for any of the affected employees.
