PURPOSE/BUSINESS CASE OF AMENDMENT OR EXTENSION, EXPECTED OUTCOMES:

Last year, SOM entered into a new contract with a new vendor for SST Kiosks. This contract shifted the burden from the State to the end users resulting in a revenue generating contract. The Kiosks were originally brought online with a limited menu of transaction options - specifically vehicle and boat registration renewal. After successful deployment and testing of these Kiosks, the State is choosing to expand the number options available to the end users. The State is adding four new transaction types with fees and two free transaction types. This is a zero cost contract to the State, the estimated increase in value is based upon additional transactions at \$3.95 each charged to the end user. These additional transactions will help MDOS provide better customer service, shifting simple transactions out of the branch to Kiosks available extended hours, shortening wait times for help by MDOS staff. PURPOSE/BUSINESS CASE OF AMENDMENT OR EXTENSION, EXPECTED OUTCOMES:

Short term, additional funds are needed to continue to service and maintain the MIDAS system, and to avoid a service disruption. With record numbers of Michigan residents relying on UI benefits at this time, the state can ill afford to fail to maintain this critical system. The contract provides for additional resources from FAST, continued batch monitoring, centralized tech service, and an SMS gateway for secure multifactor authentication (security).

Long term, the Unemployment Insurance Agency intends to negotiate new service level agreements (SLAs) governing contract performance. This includes SLAs for timeliness and quality of service provided and a set of minimum deliverables related to data reporting and transparency. The Unemployment Insurance Agency also plans to issue Requests for Information from industry partners and providers, to evaluate requirements for the state's payment operations systems partner going forward.

PURPOSE/BUSINESS CASE OF AMENDMENT OR EXTENSION, EXPECTED OUTCOMES:

Under the current State of Michigan agreement with Agate Software, Inc. the Department of Education is transitioning from its current grant (MEGS+) and cash (CMS) management systems to the most current version of Agate's IntelliGrants platform IGX. The department is utilizing ITIF project funding that was received in FY 2019 to accomplish this modernization project. The purpose of this request is to increase the Contract Value allowing for Agate to bill the ITIF project fund directly.

NexSys is replacing two critical systems, the Michigan Electronic Grants System Plus (MEGS+) and the Cash Management System (CMS), that support the departments grants process. These two systems process, award, and reimburse over \$2 billion dollars in state and federal grant funding to educational entities, child care providers, and food service providers in the state. The Federal Grants payment applications are identified as essential applications within the Department of Education's Continuity of Operation Plan, meaning GCM and MEGS+ are required to conduct essential missions and functions under all threats and conditions.

PURPOSE/BUSINESS CASE OF AMENDMENT OR EXTENSION, EXPECTED OUTCOMES:

Michigan.gov is the official portal for the State of Michigan's executive branch and all of its departments, agencies and offices. Over 1 million visitors access the State's portal each day, which currently hosts 120 web sites for residents, businesses, employees, local governments, and other customers. Established in 2001, the Michigan.gov portal was developed on the Vignette V6.0.9 content management system and vendor support for the platform ceased several years ago. eMichigan is currently under contract 071B9200124 with IBM for hosting and security services for Michigan.gov.

Beginning in January of 2020, IBM in partnership with DTMB began implementing new infrastructure to support a large Michigan.gov modernization project. The eMichigan team in conjunction with IBM and RightPoint are implementing Sitecore, a new web content management system platform. This project requires new infrastructure including virtual servers, database servers, firewalls, etc. Because Michigan.gov is a critical application, it must have high availability and 24/7 support. The current hosting contract is valid through December of 2022 and there are no option years left on the contract. When the current contract ends the infrastructure put in place for the Michigan.gov platform will be less than 2 years old and still well within the lifecycle of the equipment and software.

The benefits of extending the contract are as follows:

•Prevent charges associated with standing up new infrastructure in the selected vendors environment given the anticipated budget shortfall in FY20 and FY21. The standup cost is estimated at \$1,900,000. This estimate is based on cost associated with procuring infrastructure for development, test, production and DR environments. In addition, there will be a period before go-live (during testing) where the State will be paying for dual hosting environments. It will take 6-9 months after contract start date to go-live in the new environment and shut down the current infrastructure.

•If the contract cannot be extended the State will continue to leverage IBM as a hosting partner through the remainder of the contract (12/31/2022). There will be significant costs associated with the configuration and build out of the new hosting environment. This will cost an estimate \$1,900,000 in FY 21-22.

PURPOSE/BUSINESS CASE OF AMENDMENT OR EXTENSION, EXPECTED OUTCOMES:

The Michigan Department of Education (MDE) has been using Agate's IntelliGrants electronic grants system since 2001 with DHHS, DNR, MSP, MSHDA, and mostly recently LEO in the years following. Agate IntelliGrants allows state agencies to automate and streamline the grant life cycle. The software allows potential grantees the ability to apply for grants using a web-portal. The portal provides comprehensive information about available grant programs, eligibility requirements, information on grant writing techniques, access to key statistics, and the ability for applicants to look up grant application status. Additionally, IntelliGrants also allows the state agencies to automate the workflow required to review, approve, and deny grant applications. All these agencies have modified the system to meet their own unique needs through both configuration and customization.

In preparation for both State of Michigan contracts for grant management (HTC and Agate) to expire in 2020, Central Procurement setup a Lean Process Improvement facilitated by the Office of Performance Management. After the completion of this process, it was recommended to extend both contracts for the following reasons:

1)All agencies using both providers would be able to avoid losing substantial investments in their current solutions. In additional, the State has a perpetual license to use both systems.

2MIDC and LEO just stood up new systems in 2019 with either Agate or HTC. The implementation and customization costs being paid would all be lost for these agencies if moving to a new solution.

3)Grant Management is a candidate for transitioning to an enterprise solution which will allow the State to realize better efficiencies. However, the State needs adequate time to review the topic of grant management and plan for this transition.

4) After negotiating with both vendors, the State was able to reduce the enhancement costs, which accounts for the largest fees, by 10% for the first 2 option years. Due to the current Covid-19 budget constraints, this would greatly assist all agencies on this contract to realization cost savings.

PURPOSE/BUSINESS CASE OF AMENDMENT OR EXTENSION, EXPECTED OUTCOMES:

The Michigan Department of Health and Human Services (DHHS) has been using HTC's EGrAMS electronic grants system since 2010. The Michigan Indigent Defense Commission (MIDC) began their implementation of EGrAMS in 2019, and are now fully up and running. The HTC EGrAMS system allows DHHS to manage all aspects of the grant management process for over 3,500 grant applications. It also allows them to process a high volume of agreements with limited staff. For both agencies, the system has been highly integrated into other system through both configuration and customization.

In preparation for both State of Michigan contracts for grant management (HTC and Agate) to expire in 2020, Central Procurement setup a Lean Process Improvement facilitated by the Office of Performance Management. After the completion of this process, it was recommended to extend both contracts for the following reasons:

1All agencies using both providers would be able to avoid losing substantial investments in their current solutions. In additional, the State has a perpetual license to use both systems.

2)MIDC and LEO just stood up new systems in 2019 with either Agate or HTC. The implementation and customization costs being paid would all be lost for these agencies if moving to a new solution.

3)Grant Management is a candidate for transitioning to an enterprise solution which will allow the State to realize better efficiencies. However, the State needs adequate time to review the topic of grant management and plan for this transition.

4) After negotiating with both vendors, the State was able to reduce the enhancement costs, which accounts for the largest fees, by 10% for the first 2 option years. Due to the current Covid-19 budget constraints, this would greatly assist all agencies on this contract to realization cost savings.
