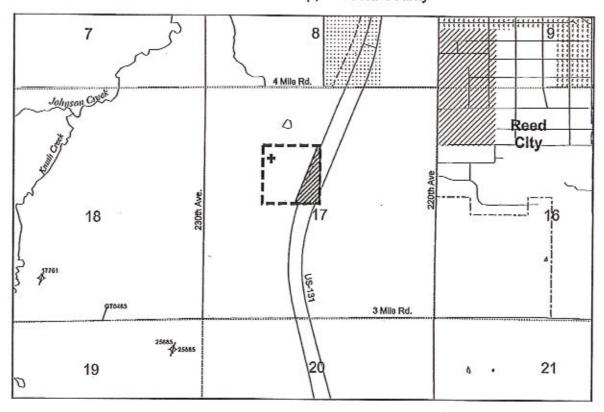

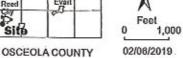

Dear Ms. Troub:

The Michigan Department of Transportation (MDOT) must obtain State Administrative Board (SAB) approval for all maintenance/construction contracts \$250,000 or greater, prior to commencement of work. In cases where MDOT determines emergency action is required, normal procedures cannot be followed prior to the beginning work. In accordance with Administrative Guide Procedure 0510.09 Emergency Purchases, a letter describing the emergency and action taken shall be submitted to notify the SAB, Civil Service Commission, and other sources, if applicable.

On May 23, 2018, the MDOT Muskegon TSC staff reached out to the Bureau of Bridges and Structures because of the rapid and unexpected deterioration of the driving surface of 3 bridges in the US-31 / M-104 Interchange. The following is the email sent to the Bureau:

"The structures on US 31 NB and SB over the M104 ramp and 3rd street north of the draw bridge in Grand Haven are deteriorating at a fast rate. We have had several challenges throughout the winter and this spring maintaining these structures to keep them safe. I have received several calls to the office from the public expressing their concern in regards to safety issues with these structures as well damage claims. Due to the location of the structures within curves as well as off ramps, accessibility is difficult making it a challenge to maintain them. I have had several occasions where it was necessary to call the Ottawa County Sherriff to assist in traffic control in order to patch up very deep and large holes. The concrete in some of the blown up areas are now getting to the second layer of rerod. If there is anything we can do to address this that would be great."

MDOT's Bureau of Bridges and Structures took the lead to administer an emergency contract to proceed with the necessary emergency repair work. Ten MDOT-prequalified contractors were contacted for a mandatory on-site pre-bid meeting that was scheduled for August 6, 2018 at 10:30 a.m. Four contractors attended the meeting. The bid due date was August 10, 2018 at 3:00 p.m. Three bids were received, and Davis Construction Incorporated was awarded the contract as the low bidder at \$391,474.10.

Davis Construction commenced work on August 19, 2018 and completed the work September 28, 2018. The project had no over runs and Davis Construction has been paid \$391,474.10 through DPO 18-11589.
