#### **Description and Justification**

The purpose of this contract is to replace and upgrade the fire suppression system at the warehouse building. The existing system does not to meet the minimum fire suppression requirements for the contents being stored at the site.

#### **Description and Justification**

The purpose of this contract is to pilot test various methods of excavating and disposing of hazardous and non-hazardous contaminated soil. The site was formerly a specialty organic chemicals storage/mixing facility that requires remediation. This work includes the removal and disposal of 475 tons of non-hazardous and 50 tons of hazardous concrete; removal and stockpiling of approximately 400 cubic yards of overburden material; removal and disposal of 3,000 tons of non-hazardous and 3,000 tons of hazardous soil; removal, treatment, and disposal of approximately 500 tons of hazardous soil; 15 days of foam and surfactant volatile organic compound control; application of soil amendments; dewatering and disposal of 2,500 gallons of non-hazardous liquids; dewatering and disposal of 1,000 gallons of hazardous liquids; and site restoration. Marie, MI 49783. The Lease is effective upon obtaining State Administrative Board approval and required signatures.
