Description and Justification

The purpose of this contract is to replace the existing sewer lift station, add a bar screen, upgrade the electrical service, and add emergency power to the lift station along with all associated miscellaneous items. Additional upgrades to the electrical service as spelled out in the alternate will also be included in the scope of work. The existing sewer lift station has met its life expectancy and is backing up causing the need for pumping trucks to remove the sewage. Currently, no bar screen exists so adding one will capture the paraphernalia that the inmates flush down the toilets out of the sewer system. **Funding Source**

This project will allow the trail to be relocated out of a low wet area into an upland location more suitable for a pedestrian trail. Failure to complete this project could result in further resource damage to the wetland area from trail users in its current location.

This Addendum is effective upon obtaining State Administrative Board approval and required signatures and continues to the termination date of January 31, 2026, or any extension. The annual per square foot rental rate for this space beginning February 1, 2021 is \$14.68 (\$8,250.00 per month). Effective August 1, 2021, the annual per square foot rental rate for this space increases to \$17.15 (\$9,640.00 per month). This is a full-service Lease. This Lease contains a Standard cancellation clause with 90-days' notice. The Attorney General has approved this Addendum as to legal form.

Purpose/Business Case:

Provides for a rate reduction for the first six months of the next available renewal option as well as exercising the option so that the Department may remain in the space for an additional five years.

Benefit:

Allows the Department to remain in space that works well of it and its clients at a reduced rate for the available renewal option for the first six months. The rate is within current market rates.


