This includes design and engineering for the shoreline revetment significant expansion to protect additional park infrastructure including septic tanks, sewer lift station, camper cabin and historical pump house, section of campground road, and several campsites; and changes to storm water control along shoreline and revetment. Description and Justification

The purpose of this modification is to provide additional professional design services to add 15 boring locations and bulk sediment chemistry and sediment porewater chemistry analyses for added sediment samples collected during remedial investigation activities of sediments in the Lower Rouge River Main Channel areas of concern. It was discovered that the River contains elevated levels of polychlorinated biphenyls, polycyclic aromatic hydrocarbons, various metals and cyanide as well as oil and grease. That was due to combined sewer overflows, sanitary sewer overflows, municipal and industrial discharges and storm water runoff. The remedial investigation will assess current conditions and fill data gaps to determine nature and extent, evaluate source controls and delineate estimate volumes of contaminated sediment to be remediated during future remedial action within the associated areas of concern. The additional boring locations and associated sampling will investigate additional areas of the river within the areas of concern that were not included in the original scope of work. The project outcomes will be used to design/implement remedial actions needed to remove beneficial use impairments within the river areas of concern. The work is needed to protect public health, safety, welfare and the environment.

Description and Justification

The purpose of this change order is to provide all labor, material, and equipment to perform additional scope of work per bulletins 6 and 7. This includes revised work in the slope revetment area, modified road access, additional revetment length along the shoreline, and revisions to the storm sewer outfall design. This work allows for the extension of the slope revetment area to protect the existing sanitary sewer system and lift station, as well as the existing buildings in that area of the campground, and ultimately, the southern campsites. The additional costs of this work are offset by the cost reduction of not having to relocate the sanitary sewer and building, which was to be bid separately as part of the overall project. This also includes a revised bathroom buildout. The bathroom refinishing was originally included in the bid documents as an alternate, however due to budget concerns and high pricing, the alternate was not selected at the time. During building relocation planning, an option to carry the existing slab and interior wall of the bathroom was presented. While the slab did require steel reinforcement, there would be significant savings on the wall construction from the original alternate bid. The altered dimensions did require redesign of the interior.

AGREEMENT FOR THE CONSTRUCTION OF A WATER MAIN AND THE PROVISION OF WATER SUPPLY SERVICES

1. DEPARTMENT OF TECHNOLOGY, MANAGEMENT AND BUDGET, LANSING New State Psychiatric Hospital – Water Main Construction and Supply

That the agreement between the Michigan Department of Technology, Management and Budget and City of Caro be approved for \$1,773,538.00.

Purpose/Business Case

The purpose of this agreement is to provide for the construction and provision of water supply services to the new State Psychiatric Hospital, in Caro. The project was initially proposed with the intent that the existing public water main from the City of Caro will be extended to provide water to the new building site. The existing Caro Center elevated water storage tank and current underground distribution system were originally constructed back in 1938. Due to their age and condition, these components are not recommended to support the new hospital. The City of Caro commissioned a detailed water supply study to evaluate the impact of extending and connecting the new 100-bed hospital to their existing public water system. The results of the study confirmed that the City of Caro has sufficient water supply and pressure to permit connection of the new hospital. The subject agreement formalizes that the City of Caro will undertake the design and construction components to extend their system and the State of Michigan will reimburse the City of Caro for suitable construction expenditures. The City has followed their procurement process and the water main expenditures have been assembled at \$1,773,538.00.

Funding Source

100% State Building Authority Funds

ROADWAYS ABANDONMENT ACCEPTANCE

 DEPARTMENT OF TECHNOLOGY, MANAGEMENT AND BUDGET (DTMB), TOWNSHIP OF INDIANFIELDS, TUSCOLA COUNTY: A recommendation and request that the State Administrative Board (SAB) authorize DTMB to facilitate and accept, on behalf of the Department of Health and Human Services (DHHS), a permanent abandonment of certain Tuscola County roadway sections which are needed to facilitate the planned replacement of the DHHS Caro Center psychiatric hospital campus located at 2000 Chambers Road, Caro, Michigan 48723. The subject roadway sections are situated in Sections 19 and 20, Town 12 North, Range 9 East, Indianfields Township, Tuscola County, Michigan, and are further described as follows:

- 1. The portion of Wells Road to be abandoned and discontinued includes the western edge of Wells Road at its intersection with Graf Road proceeding east through its intersection with Chambers Road, depicted in yellow on the attached drawing, Attachment A.
- 2. Campus Street (a/k/a Main Street or Caro Road) is to be abandoned and discontinued in its entirety from its western intersection with Dickerson Drive proceeding east through its eastern intersection with Wells Road and Graf Road, depicted in yellow on the attached drawing, Attachment A.
- 3. The portion of Graf Road to be abandoned and discontinued includes the southern portion of Graf Road from its intersection with Center Street south to its intersection with Wells Road, depicted in yellow on the attached drawing, Attachment A.
- 4. Jefferson Street is to be abandoned and discontinued in its entirety from its western intersection with Dickerson Drive proceeding east through its eastern intersection with a Private Drive located in Section 20, T12N, R9E, Indianfields Township, Tuscola County, Michigan and f/k/a River Street North, depicted in yellow on the attached drawing, Attachment A.
- 5. Dickerson Drive is to be abandoned and discontinued in its entirety from its northern intersection with Center Road proceeding south to its termination in Section 19, T12N, R9E, Indianfields Township, Tuscola County, Michigan, depicted in yellow on the attached drawing, Attachment A.
- 6. River Street North (a/k/a Private Drive) is to be abandoned and discontinued in its entirety from its northern intersection with Wells Road proceeding south to its intersection with Jefferson Street and termination in Section 20, T12N, R9E, Indianfields Township, Tuscola County, Michigan, depicted in yellow on the attached drawing, Attachment A.

Excluding in each case any existing easements and restrictions of record, if any.

The subject roadways are illustrated in Attachment A. (One page.)

At its meeting duly held on February 17, 2021, Indianfields Township collected signatures of the required 7 freeholders on a petition of its own design asking Tuscola County to abandon the aforementioned county road segments. That petition includes space for the required acknowledgement by the State that it is the sole owner of all land

abutting the subject road segments. With SAB approval of this request, that acknowledgment would be executed by the DTMB Director or his designee.

Purpose:

The design and construction of the new 100-bed State Psychiatric Hospital on the grounds of the current Caro Center is envisioned to provide a safe, efficient, and modern environment for both patients and facility staff. The completed project site analysis and programing requirements recommend utilizing the aforementioned roadways to accomplish the overall new facility layout. Abandonment of same in favor of the State is the preferred approach to secure that needed space through the normal roadway abandonment procedures prescribed in the Public Highways and Private Roads Act (Public Act 283 of 1909, as amended. See, e.g., MCL 224.18).

Benefit:

Allowing the State to accept the aforementioned road segments abandonments in a timely manner will help ensure that the New State Psychiatric Hospital construction project can in turn continue to proceed without added construction costs caused by delay. Another major component of acquiring the subject property will also improve the security perimeter for the eventual new hospital campus. Indianfields Township has already expressed formal support for these road abandonments and Tuscola County Road Commission staff have expressed informal support for it as well. Finally, abandoning these under-utilized county road segments to the State will not deprive other landowners of effective and convenient public road access to their own property.

Funding Source:

Out of pocket costs for surveying and otherwise facilitating the aforementioned roadway abandonments in favor of the State will be paid via the DTMB Design and Construction Division's Caro Center psychiatric hospital expansion project budget.

Commitment:

These roadway abandonments would be permanent real property additions to the stateowned Caro Center psychiatric hospital campus.

Risk Assessment:

Failure to accept these roadway abandonments as additions to the Caro Center psychiatric hospital campus will jeopardize plans for constructing the New Caro Center and required parking to serve the hospital itself.
