Houghton Ave., in the City of West Branch, County of Ogemaw and further described below, to the City of West Branch for consideration of \$1.00. The Office of the Attorney General has approved the quitclaim deed as to legal form.

#### **Background:**

The State acquired the subject property from the City of West Branch vin consideration of \$1.00 in a 1939 deed which contains the following provision: "...upon discontinuance of the use of said lands by the Michigan State Police, the title to said described lands shall revert to said City of West Branch;...Together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining to;..." DTMB hereby submits that the best interests of the State require that that the letter and spirit of the reverter provision in the 1939 deed be honored at this time by conveying the property to the City of West Branch "as is" with all hereditaments and appurtenances thereunto via a quit claim deed in consideration of \$1.00.
