MICHIGAN STATE POLICE, TRAVERSE CITY – New Lease No. 12218 with Traverse City Area Public Schools, a Michigan Municipal Corporation, 412 Webster St, Traverse City, MI 49686, as Lessor, and the State of Michigan by the Department of Technology, Management & Budget for the Michigan State Police, as Lessee, for 2,600 square feet of office space located at 2075 Cass Road, Traverse City, MI 48686. 13. MICHIGAN STATE POLICE, SANDSUKY - Addendum No. 1 to Lease No. 323-1940-1, between Sanilac County, Courthouse, 60 W. Sanilac Ave, Sandusky, MI 48471, as Lessee, and the State of Michigan by the Department of Technology, Management & Budget for the Michigan State Police, as Lessee, for 2,100 square feet of land located at 90 W. Sanilac, Sandusky, MI 48471. This Addendum provides for monthly installment payments to cover the cost of lawn maintenance and snow removal and add cancellation language. This Addendum is effective upon obtaining State Administrative Board approval and required signatures and continues to the termination date of the April 22, 2039, or any extension. The monthly installment payment is \$1,000.00. This Lease contains a Standard cancellation clause with 90-days' notice. The Attorney General has approved this Addendum as to legal form.

GRANT OF EASEMENT

14. DEPARTMENT OF TECHNOLOGY, MANAGEMENT AND BUDGET (DTMB), TOWNSHIP OF HENRIETTA, JACKSON COUNTY: A recommendation and request that the State Administrative Board grant to The Township of Henrietta, with offices at 11732 Bunkerhill Road, Pleasant Lake, MI 49272, a permanent non-exclusive easement for installing, constructing, operating, maintaining and repairing a water well, fire hydrant and related appurtenances, along with an ingress/egress corridor thereto, on land (the Land) which is under the jurisdiction of the Department of Corrections and located in The Township of Henrietta,

County of Jackson, Michigan. This State of Michigan property is under the administrative jurisdiction of the Michigan Department of Corrections. The easement area is described thusly:

Easement area for the water well:

Commencing at the South ¼ corner of Section 5, Town 2 South, Range 1 East, Henrietta Township, Jackson County, Michigan; thence S 88°57′51″ W 177.69 feet along the south line of said Section 5; thence N 01°02′09″ W 24.51 feet to the POINT OF BEGINNING; thence continue N 01°02′09″ W 22.00 feet; thence S 88°57′51″ W 18.00 feet; thence S 01°02′09″ E 22.00 feet; thence N 88°57′51″ E 18.00 feet back to the POINT OF BEGINNING.

Easement area for the ingress/egress corridor to the water well:

Commencing at the South ¼ corner of Section 5, Town 2 South, Range 1 East, Henrietta Township, Jackson County, Michigan; thence S 88°57′51″ W 33.00 feet along the south line of said Section 5 to the west right-of-way line of Hawkins Road; thence N 00°03′28″ W 46.52 feet along the west right-of-way line of Hawkins Road to the POINT OF BEGINNING; thence S 88°57′51″ W 163.48 feet; thence N 01°02′09″ W 20.00 feet; thence N 88°57′51″ E 163.83 feet to the west right-of-way of Hawkins Road; thence S 00°03′28″ E 20.00 feet back to the POINT OF BEGINNING.

All subject to agreements, covenants, easements, right-of-ways, reservations and restrictions of record, if any. The Office of the Attorney General has approved this grant of easement as to legal form.

Purpose:

An easement on State property allowing Henrietta Township to install, construct, operate, maintain and repair a water well, fire hydrant and related appurtenances on State of Michigan property under the administrative jurisdiction of the Department of Corrections.

Benefit:

Granting this easement will allow the State to accommodate Henrietta Township's request to site a water well and fire hydrant in a location it has deemed advantageous for township purposes, and it will allow the State to earn revenue of \$806.44 for the General Fund in (less \$250.00 to the Department of Management, Technology and Budget for its related expenses) in accordance with the Easement Fee Schedule adopted by the State Administrative Board on January 18, 2011. It will also develop a potential new water source on state land that may also be used for firefighting on surrounding State lands if ever needed.

Commitment:

This will be a permanent, non-exclusive easement subject to existing easements and restrictions of record, if any. If the easement remains unused for a period of two years, it will revert to the State of Michigan as Grantor.

Risk Assessment:

Failure to grant this easement will preclude the State from accommodating Henrietta Township's water well needs and from earning revenue for the fair value of the easement.
