GRANT OF EASEMENT

11. DEPARTMENT OF TECHNOLOGY, MANAGEMENT AND BUDGET (DTMB) FOR THE DEPARTMENT OF HEALTH AND HUMAN SERVICES, INDIANFIELDS TOWNSHIP, TUSCOLA COUNTY: A recommendation and request the State Administrative Board grant to DTE ELECTRIC COMPANY, with offices at One Energy Plaza, 23 WCB, Detroit, Michigan 48226, a permanent non-exclusive easement for purposes of constructing, reconstructing, modifying, adding to, repairing, replacing, inspecting, operating and maintaining underground utility line facilities, which may consist of poles, guys, anchors, wires, manholes, conduits, pipes, cables, transformers and accessories as needed to provide electric power to a City of Caro sewer lift station, which itself is dedicated to serving State of Michigan property, and running across land under the jurisdiction of the Michigan Department of Health and Human Services

(DHHS) located at 2040 Chambers Road, Caro, Michigan. The easement area is located on land situated in the Northeast 1/4 of Section 19, and the Northwest 1/4 of Section 20, Town 12 North, Range 9 East, Indianfields Township, Tuscola County, Michigan, more particularly described as follows to-wit:

Part of the Northeast 1/4 of Section 19, and in part of the Northwest 1/4 of Section 20, Town 12 North Range 9 East, Indianfields Township, Tuscola County, Michigan and more particularly described as a 30 foot wide easement being 15 feet each side of the following described centerline: Commencing at the Northeast corner of Section 19, Town 12 North, Range 9 East; thence South 87°55'11" West, along the North line of said Section 19, 155.62 feet; thence South 02°04'49" East 169.13 feet to the Point of Beginning of the centerline of this easement description; thence South 06°46'57" West 582.68 feet; thence South 14°26'10" East 569.09 feet; thence South 01°48'41" West 647.65 feet; thence South 49°57'19" East 340.04 feet; thence South 44°37'39" West 887.33 feet to the existing sanitary pumping station and the Point of ending.

The described easement centerline is 1606 feet and easement area is 0.73 acres of land, more or less.

Subject to all agreements, covenants, easements, right-of-ways, reservations, and restrictions of record, if any.

The Office of the Attorney General has approved this easement agreement as to legal form.

Purpose:

The City of Caro is constructing a sewer lift station to serve the State's new Caro Center hospital which is itself now under construction at 2040 Chambers Road in Caro, MI. That facility needs electric power to operate and the most efficient route to run that transmission line is over the state land described above. This easement allows DTE Electric Company to install, operate and maintain that electric power transmission line.

Benefit:

Granting this easement to DTE Electric Company will enable the State to ensure the sewer lift station serving its Caro psychiatric hospital can have electric power it needs to operate.

Commitment:

This easement will be a permanent, non-exclusive easement subject to existing easements and restrictions of record, if any.

Risk Assessment:

Failure to grant this easement to DTE Electric will preclude the municipal sewer lift station dedicated to serving the State's Caro Center hospital from having essential electric power to operate.

Amendatory Contract (2017-0342/A5) between MDOT and Beam, Longest & Neff, LLC, will increase the maximum contract amount by \$1,449,481.59, and will extend the contract term by approximately 48 months to provide for the continuation of owner's representative consultant services, including the management of demolition-related activities for additional parcels, for the Gordie Howe International Bridge project. The original contract provides for the consultant to act as MDOT's representative for the procurement of parcels and the oversight and management of demolition-related activities for approximately 280 parcels in the Delray area of the City of Detroit, Michigan, for the Gordie Howe International Bridge project. The revised contract term will be May 23, 2016, through May 26, 2027. The revised contract amount will be \$20,350,135.98. Source of Funds: 100% Windsor-Detroit Bridge Authority Funds.
2. **HIGHWAYS – Inspection and Testing Services**
Contract (2023-0292): MDOT will enter into a contract with a consultant that will provide for as-needed inspection and testing services to be performed for MDOT projects at various locations in the Jackson Transportation Service Center service area.
