Description and Justification

The purpose of this modification is to continue the implementation of a soil vapor extraction (SVE) pilot study and monitor site conditions to evaluate the implemented enhanced reductive dichlorination (ERD) remedy. The site has been identified as having impacted soil and groundwater due to the historic use of chlorinated solvents. Present in the site's soil and groundwater is predominantly chlorinated ethenes, chromium and nickel. The implemented ERD treatment/process requires monitoring and evaluation, and the site requires additional technologies to address the environmental contamination. The tasks include 3 limited and 1 full groundwater and surface water sampling events; 4 semi-annual soil gas sampling events; extending the SVE pilot study through June 2023; modifying the SVE system to operate passively with assistance from solar power; pilot SVE operation and maintenance; waste characterization and disposal; and reporting. The work is needed to protect public health, safety, welfare, and the environment.

- 3. The state reserves all aboriginal antiquities including mounds, earthworks, forts, burial and village sites, mines, or other relics lying on, within, or under the property with power to this state and all others acting under its authority to enter the property for any purpose related to exploring, excavating, and taking away the aboriginal antiquities.

The net revenue received from the sale of the Property must be distributed as follows: 100% General Fund.

Purpose/Business Case:

This conveyance satisfies all requirements and other criteria set forth in Public Act 231 of 2022 which authorizes it.

Benefit:

This conveyance relieves the Dept. of Michigan State Police of all liability and responsibility for this unused surplus property. It also allows Kent County government to return the subject property to productive use in service to its Kent County Health Department which has its main offices in close proximity to the subject property.

Risk Assessment:

Failure to approve this sale would preclude the opportunity for the State to end its ownership obligations for the subject property which is surplus to its needs and prevent it from being returned to productive reuse by Kent County.
