
Ms. Bliesener called the meeting to order.

(PAHs), various metals and cyanide as well as oil and grease, that were due to urban and industrial development, combined sewer overflows, municipal and industrial discharges, and storm water runoffs. The professional will add upstream data for samples collected at the Riverside Park Shoreline and Harbortown areas and data from six other historical site characterizations. The recorded data will be used to estimate volumes of contaminated sediment for implementing future remediation activities. LEASE FOR PRIVATE PROPERTY

19. DEPARTMENT OF CORRECTIONS, DETROIT - Renewal Lease No. 10965-2022 by and between 5300 Lawton, Inc., whose address is 33200 Mound Road, Sterling Heights, MI 48310, as Lessor, and the State of Michigan by the Department of Technology, Management & Budget for the Department of Corrections, as Lessee, for 38,494 square feet of office and 2,280 square feet of garage space located at 2777 W. Edsel Ford (a/k/a 5300 Lawton), Detroit, MI 48208. The Lease is effective upon obtaining State Administrative Board approval and required signatures. The annual per square foot rental rate for this space beginning September 1, 2023, is \$21.63 (\$65,275.74 per month) for the office space and \$5.93 (\$1,126.70 per month) for the garage space. These rates do not include public utilities, janitorial services and supplies, dumpster service and pest control. This Lease contains two 5-year renewal options with an annual per square foot rental rate of \$23.98 (\$72,367.64 per month) and \$26.91 (\$81,209.90 per month), for the office space and \$6.93 (\$1,316.70 per month and \$7.33 (\$1,392.70 per month) for the garage space, respectively. This Lease contains an Executive Cancellation clause with 180-days' notice for the initial lease term and a Standard Cancellation clause with 180-days' notice for any renewal options. The Attorney General has approved this Lease as to legal form. This Lease meets the criteria requiring approval of the Joint Capital Outlay Subcommittee of the Legislature. The Subcommittee approved this Lease on June 7, 2023.

Purpose/Business Case:

The renewal of this Lease for the Department of Corrections will provide much needed improvements to the current facility while continuing to offer a location that that meets the Department's needs within Wayne County.

Benefit:

The benefit of this lease renewal allows for needed improvements at a location that works well for the Department and its clients within Wayne County. The rental rate is within market rate for comparable space.

Commitment Level:

Ten years; however, this Lease contains two 5-year renewal options and an Executive Cancellation clause with 180-days' notice for the initial lease term and a Standard Cancellation clause with 180-days' notice for any renewal options.
