DEPARTMENT OF TECHNOLOGY, MANAGEMENT AND BUDGET (DTMB), TOWNSHIP OF WINDSOR, EATON COUNTY: A recommendation and request that the State Administrative Board grant to Consumers Energy Company, a domestic for-profit corporation with offices at One Energy Plaza, Jackson, Michigan 49201, a permanent non-exclusive easement for purposes of installing, constructing, operating, maintaining, inspecting, repairing, supplying and accessing an electric power substation dedicated to serving the State of Michigan's Camp Tushmaheta facilities located at 10500 Lincoln Lake Road Northeast, in the Northwest 1/4 of Section 23, and in the Northeast 1/4 of Section 23, Township 9 North, Range 9 West, Oakfield Township Kent County, Michigan (the Easement) on land (the Land) which is under the jurisdiction of the Michigan Department of Education ("MDE") and more particularly described as follows:

Installing, constructing, operating, maintaining, inspecting, repairing, supplying and accessing an electric power substation dedicated to serving the State of Michigan's Camp Tuhsmeheta property by providing electric power to a new "nature center" facility there. **Benefit:** 

The easement will allow the Camp Tuhsmeheta nature center to be opened and operated as intended.

### Commitment:

This easement will be a permanent, non-exclusive easement subject to existing easements and restrictions of record, if any. If the easement remains unused for a period of two years, it will revert to the Grantor.

### **Risk Assessment:**

Failure to grant this easement will preclude the State from opening and operating the Camp Tuhsmeheta nature center as intended and thus from realizing the return on that investment.
