The electric power lines facilitated by these four easements will provide electric power service for the new State Public Health and Environmental Science Lab currently under construction at the State Secondary Center and eventually to other State facilities as well.

#### **Commitment:**

These four easements will be permanent, non-exclusive easements subject to existing easements and restrictions of record, if any. If the easements remain unused for a period of two years, they will revert to the Grantor. They are intended to work with a similar adjacent fifth LVD buried power line easement which is simultaneously offered and recommended to the State Administrative Board (SAB) by the State Building Authority (SBA) for the same purposes.

## **Risk Assessment:**

Failure to grant these four easements will preclude the State from having permanent electric power service for the new State Public Health and Environmental Science Lab currently under construction at the State Secondary Center and eventually to other State facilities as well. It could also leave the related SBA easement stranded with no way to legally connect permitted electric power line infrastructure there to Consumers Energy Company's electric power grid.

  Contract (13000-221278-202) between MDOT and Universal EV LLC., will provide installation of a Direct Current Fast Charging (DCFC) charging station through the National Electric Vehicle Infrastructure (NEVI) program at 400 B-Drive N in the city of Albion, Calhoun County. The contract will be in effect from the date of award through October 1, 2027. The contract amount will be \$1,011,980.00. Source of Funds: 80% Federal Highway Administration, and 20% Private Funding.
- \*PASSENGER TRANSPORTATION Increase Services and Amount Amendatory Contract (2024-0108/A3) between MDOT and HNTB Michigan, Inc., will expand the grant project and increase access to static and real-time public transit options in rural communities and will increase the contract amount by \$1,342,374.37 in state funds. The original contract provides federal funds under the FY 2023 Strengthening Mobility and Revolutionizing Transportation (SMART) Grants Program for project management, discovery, development, and initial implementation for the Advancing Rural Mobility pilot project to improve public access to static and real-time data for rural transit agencies. The contract term remains unchanged, August 15, 2023, through February 15, 2027. The revised contract amount will be \$2,692,422.88. Project Authorization (53) under Master Agreement (2012-0200) between MDOT and the National Railroad Passenger Corporation (Amtrak) will provide funding for the procurement of 42 gate mechanisms for the Michigan Line corridor from Dearborn to Kalamazoo. MDOT will compensate Amtrak for eligible costs under the approved scope of work and estimate. The authorization will be in effect from September 11, 2025, through May 1, 2027. The authorization amount will be \$2,148,241.51. The term of the master agreement is December 7, 2012, through September 30, 2032. Source of Funds: State Restricted Trunkline Funds - \$2,148,241.51.

## 20. RAIL - Procurement of Wayne Diamonds

Project Authorization (54) under Master Agreement (2012-0200) between MDOT and the National Railroad Passenger Corporation (Amtrak) will provide funding for the procurement of Wayne Diamonds for the Michigan Line corridor at control point (CP) 18 on Main 1 and Main 2. MDOT will compensate Amtrak for eligible costs under the approved scope of work and estimate. The authorization will be in effect from September 11, 2025, through December 31, 2027. The authorization amount will be \$2,529,488.99. The term of the master agreement is December 7, 2012, through September 30, 2032. Source of Funds: State Restricted Trunkline Funds - \$2,529,488.99.

## 21. RAIL - Procurement of Ties

Project Authorization (55) under Master Agreement (2012-0200) between MDOT and the National Railroad Passenger Corporation (Amtrak) will provide funding for the procurement of 20,000 ties for the Michigan Line corridor from Kalamazoo to Battle Creek. MDOT will compensate Amtrak for eligible costs under the approved scope of work and estimate. The authorization will be in effect from September 11, 2025, through December 31, 2027. The authorization amount will be \$6,848,118.99. The term of the master agreement is December 7, 2012, through September 30, 2032. Source of Funds: State Restricted Trunkline Funds - \$6,848,118.99.

## 22. RAIL - Procurement of Continuously Welded Rail

Project Authorization (56) under Master Agreement (2012-0200) between MDOT and the National Railroad Passenger Corporation (Amtrak) will provide funding for the procurement, transportation, unloading, and securing of 50 strings of continuously welded rail for the Michigan Line between control point (CP) 75 and CP 28. MDOT will compensate Amtrak for eligible costs under the approved scope of work and estimate. The authorization will be in effect from September 11, 2025, through December 31, 2026. The authorization amount will be \$7,314,299.54. The term of the master agreement is December 7, 2012, through September 30, 2032. Source of Funds: Federal Railroad Administration Funds - \$1,737,476.24; State Restricted Trunkline Funds - \$5,576,823.30.

# 23. RAIL - Increase Amount

Amendatory Contract (2021-0851/A1) between MDOT, the Illinois Department of Transportation (IDOT), the Wisconsin Department of Transportation, and the Missouri Department of Transportation will increase the contract amount by \$3,447,989.36 to cover the remainder of the equipment costs. The original Memorandum of Agreement (MOA) sets forth the terms and conditions of sharing in the equipment costs relating to fleet manager expenses, equipment modifications, and overhauls for the Midwest-owned passenger rail equipment.   Authorization (8) under Master Agreement (2024-0005) between MDOT and the
  Kalamazoo Area Transportation Study (KATS) will provide for the undertaking of
  transportation planning activities at the local and regional levels. The authorization will
  be in effect from October 1, 2025, through September 30, 2026. The authorization
  amount will be \$758,970. The term of the master agreement is October 1, 2023, through
